We hereby submit that as per the sub para 7C of Para A of Schedule III of SEBI (LODR), 2015 "In case of resignation of key managerial personnel, senior management, Compliance Officer or director other than an independent director; the letter of resignation along with detailed reasons for the resignation as given by the key managerial personnel, senior management, Compliance Officer or director shall be disclosed to the stock exchanges by the listed entities within seven days from the date that such resignation comes into effect."

Hence, we were of the view that it has to be given within seven days from the effective date of Resignation along with the Resignation letter.

However, for future we have noted the timeline prescribed under the SEBI circular SEBI/HO/CFD/CFD-PoD 1/P/CIR/2023/123 dated 13th July, 2023 and we will be more vigilant henceforth.

Further, we would like to inform you again that Mr. Ankit Kumar Srivastava, Company Secretary and Compliance Officer has resigned from his position for pursuing an alternate career opportunity outside the organization and there are no other material reasons and he has been relieved from the services of the Company with effect from the closing hours of 17th August, 2024.
