Dear Madam,

I, Santosh Kumar Tibrewalla, Practising Company Secretary has been appointed by the Board of Directors of M/s. Adarsh Mercantile Limited (the Company) as Scrutinizer as per the provisions of Section 108 /109 of the Companies Act, 2013 read with Rule 20 & 21 of the Companies (Management and Administration) Rules, 2014, for the purpose of scrutinizing the process of remote e-voting & voting carried out by means of Ballot papers at the venue of the Annual General Meeting of the Equity Shareholders of the Company and ascertaining the requisite majority on voting carried out on the resolutions contained in the notice to the Annual General Meeting (AGM) of the members of the Company, held on Monday, the 16th day of September, 2024 at the Registered Office of the Company at 8A & 8B, Satyam Towers, 3, Alipore Road, Kolkata - 700027 at 12.30 P.M.

1. The Management of the Company is responsible to ensure the Compliance with the requirements of the Companies Act, 2013, Rules made thereunder and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to voting through electronic means & ballot paper on the resolutions contained in the Notice to the Annual General Meeting (AGM) of the members of the Company. My responsibility as a Scrutinizer for the voting process is restricted to make a Scrutinizer's report of the votes cast in "favour" or "against" the resolutions stated above, based on the reports generated from the remote e-voting system provided by the Central Depository Services Limited (CDSL), the authorised agency to provide remote e-voting facilities, engaged by the Company and voting conducted by means of Ballot Papers at the venue of the Annual General Meeting.
2. Further to the above, I submit my report as under:-
 - i) The remote e-voting period remained open from Friday, September 13, 2024 (10.00 A.M.) up to Sunday, September 15, 2024 (5.00 P.M.).
 - ii) The members of the Company as on the "cut-off" date i.e. Monday, September 9, 2024 were entitled to vote on the resolutions (items no. 1, 2 & 3 as set out in the notice of the AGM of the Company).
 - iii) The facility of Ballot voting was provided at the venue of the AGM only to those members present who had not casted their votes by remote e-voting.



- iv) The ballot box for voting by means of ballot paper was locked and sealed by me in the presence of the members and proxies present at the Annual General Meeting.
- v) On conclusion of the Voting at the venue of the AGM held on 16th September, 2024, the ballot box was opened by me in the presence of 2 witnesses, Ms. Aditi Prasad Mahto and Mr. Rahul Singh. The votes casted through Ballot Papers were duly scrutinized and were reconciled with the records maintained by the Registrar and Share Transfer Agents of the Company and the authorisations / proxies lodged with the Company.
- vi) No ballot paper was found to be incomplete or defective. The votes casted through e-voting are also found to be in accordance to the rules provided.
- vii) Thereafter, votes casted through remote e-voting were unblocked on 16th September, 2024 in the presence of 2 witnesses, Ms. Aditi Prasad Mahto and Mr. Rahul Singh, who are not in the employment of the Company.
