In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that, the Company has received notice from National Stock Exchange of India Limited (NSE) and E-mail from BSE Limited (BSE) on 20th February 2025 regarding Non-compliance of appointment of qualified company secretary as the compliance officer for a period of 22 days under the provisions of Regulation 6(1) of the SEBI (LODR) 2015 and has imposed a fine of Rs.22,000/- each by NSE & BSE for such non-compliance.

To comply with the statutory provisions, on recommendation of the Nomination and Remuneration Committee, the Board of Directors in their meeting held on 12th November 2024 have approved the appointment of Mr.P. Mahadevan (FCS 9150) as Company Secretary and Compliance Officer of the Company.

Hence, we confirm that, the company had already complied the provisions of Regulation 6(1) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The company has paid the fine amount to the stock exchanges on 21.02.2025.
