We acknowledge receipt on email dated 13.12.2024 cited above alleging Non Compliance with Disclosure of Related Party Transactions on Consolidated basis and consequent violation of Regulation 23(9) of SEBI LODR Regulations 2015

We request reference to Regulation 15(2) (a) of Chapter IV of SEBI LODR Regulations 2015, the provision of Regulation 23(9) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended are not applicable to our company since our paid up equity share capital does not exceed Rs. 10 crore and net worth does not exceed Rs.25 crore, as on the last day of the previous financial year (ie. 31.03.2024). Hence, our company is **not required to submit** "Disclosure of Related Party Transactions for the half year ended 30<sup>th</sup> September 2024 as required under Regulation 23(9) of the SEBI (LODR) Regulations, 2015."

As on the last day of the previous Financial year which is March 31<sup>st</sup> 2024, the Equity Share Capital and Net worth of the Company were as under :
