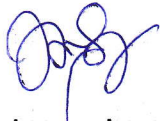

As per Rule 19A (5) of the Securities Contracts (Regulations) Rules, 1957, the minimum public shareholdings at the time of listing is 5%. When the resolution plan was approved by the CoC, this condition was not taken into account. Now the applicant wants to replace para no.7 of part VII of the resolution plan with para no.7 by the additional memorandum dated 22.08.2024. The resolution plan was approved by the CoC on 17.09.2021 and by this Authority on 25.05.2023.

In these circumstances, we deem it fit to allow the application. Accordingly, para no. 7 of part VII of the resolution plan is replaced with para no. 7 of the additional memorandum dated 22.08.2024 and the table is reproduced as below which shall become part of the resolution plan approved by the CoC on 17.09.2021.

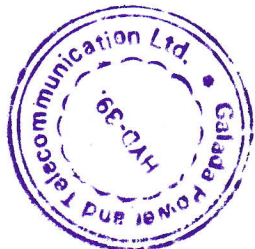

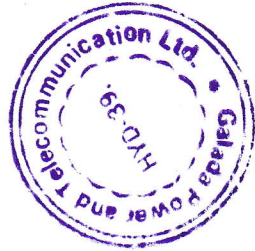
