With reference to the announcement made on BSE dated November 16, 2023 captioning “Droneacharya Aerial Innovations Limited wins Tender worth Rs. 96,00,000.00 for training 240 officials from the Karnataka Forest Department”, we are pleased to inform the stakeholders that DroneAacharya Aerial Innovations Limited has been granted approval by the Directorate General of Civil Aviation (DGCA) for its 5th Remote Pilot Training Organization (“RPTO”) at Dharwad, Karnataka, in association with the Karnataka Forest Academy.
