

'You Will Be Chief Minister One Day', CM Devendra Fadnavis Tells His Deputy Ajit Pawar

Mumbai, Sachin Murdeswar: Maharashtra Chief Minister Devendra Fadnavis on Thursday said he and his deputies Ajit Pawar and Eknath Shinde would work 24/7 in shifts. "Ajit Pawar will work in the morning since he is an early riser. I am on duty from 12 noon to midnight while throughout the night... you all know who," Fadnavis said, referring to Shinde, who is known to work till late hours. He was replying to a debate in the legislative assembly on the motion of thanks to the Governor

for his joint address to both Houses of the state legislature during the ongoing Winter Session in Nagpur. Turning to Ajit Pawar, Fadnavis said, "You are called 'permanent deputy CM'... but my wishes are with you... you will be the CM someday." Ajit Pawar on December 5 took oath as the deputy CM of Maharashtra for the sixth time. The NCP leader, who has been vocal about his chief ministerial ambitions, split the Sharad Pawar-founded Nationalist Congress Party in



2023 and joined the BJP-led Mahayuti government. In the ensuing battle for the party name and its 'clock' symbol, his faction got both. His uncle and veteran politician Sharad Pawar now heads NCP (SP), an ally of the

Congress and Shiv Sena (UBT) under the banner of the MahaVikasAghadi. After a severe drubbing in the Lok Sabha polls that saw NCP bagging only one seat, Ajit Pawar's party made an impressive comeback in the recently held assembly elections, emerging victorious in 41 of the 57 constituencies where it was in the fray. The Mahayuti alliance of BJP, Shiv Sena and NCP won over 230 of the state's 288 assembly seats, while MVA could manage to grab only 46.

Mumbai Tragedy: Ferry Was Overcrowded, Passengers Given Life Jackets After Accident, Say Police Sources

Mumbai, Suresh Dhare:

The ferry that collided with a Navy speedboat in Mumbai's Colaba on Wednesday was carrying over 110 passengers against the permitted limit of 90, which included six crew members, preliminary probe has revealed. Sources in the Mumbai Police also told News18 that according to rules, passengers are supposed to wear life jackets once they sit in the ferry. However, life jackets were given to them after the accident in clear violation of rules. At least 13 people have died and two others are in critical condition after a collision between the ferry Neelkamal, which was headed to the Elephanta Caves—a popular tourist destination—and a navy speedboat that was conducting a trial drive. The caves, located on an island in the Sea of Oman and a short ferry



ride from Mumbai, are one of the city's most popular tourist destinations and are a UNESCO World Heritage Site. Two passengers, a man and a child, are still missing a day after the accident, police said on Thursday. They have been identified as 43-year-old Hansraj Bhati and seven-year-old Johana Mohammad Nisar Ahmed Pathan, the police said. Sources said police have so far recorded statements of nine individuals regarding the accident, which also involved three foreign

nationals—two from Germany and one from Canada. Six individuals were aboard the Navy trial boat during the accident of whom four lost their lives and two sustained serious injuries. Of the 13 fatalities, eight bodies have been handed over to the families. Sources also said Mumbai Police will inspect the Navy's trial boat involved in the accident and get in touch with navy officials for necessary permissions and details. The drivers of some boats who rushed to help the victims after the accident said they had never witnessed such a horrific incident in their lives. Speaking to news agency, Arif Bamane, a driver of the Mumbai Port Trust (MBPT) pilot boat Poorva, said: "When we reached there, the situation was tragic and completely chaotic. People were screaming for help, and some were crying." With 18 years of

boat driving experience, Bamane said he had witnessed small rescue operations before but Wednesday's incident was the most horrific and tragic. Iqbal Gotheekar, the driver of a small tourist boat, told that 25-30 minutes after his boat departed from the Elephanta Island at 3.35 pm, he learned about the incident and was one of the first to reach the accident site. He said the passengers were frantically waving their hands for help and his boat rescued 16 people, bringing them safely to the Gateway of India.

Artificial intelligence i.e. 'AI' has provided a way for every person working in the media to become more informed. The limitations that existed in the knowledge available in our mother tongue have now been reduced through 'AI'. Information is easily available in the language in which we need it. Therefore, instead of staying away from artificial intelligence, it is the responsibility of all of us to understand the technology and make it more perfect through our use, asserted Brijesh Singh, Principal Secretary and Director General of the Information and Public Relations Department. He was speaking at a program organized by the Nagpur Press Club and the Nagpur office of the Directorate General of Information and Public Relations on the topic of 'Artificial Intelligence in Journalism'. Senior journalist and former State Information Commissioner Rahul Pandey said, along with the inherent quality within us, it is necessary to make proper use of artificial intelligence. To ensure that 'AI' is not used to commit anti-India acts, it is necessary to prepare Marathi language will also have to be linked to 'AI'. Rahul Pandey also expressed the hope that more such workshops should be organized. We should approach 'AI' with caution in the definition of constitutionality and truth-falsehood, in the same perspective that we see other living beings as individuals, as humans. Any curiosity leads us to the sources of knowledge. Earlier, we satisfied this curiosity by connecting it to Google. Now, as a further step of this curiosity, we have to look at the information available through 'AI', he said.
