EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

Item 1: Re-appointment of Mr. Rajvir Singh Chhillar (DIN: 08651668) as Independent Director:

The Board of Directors, based on the recommendation of the Nomination and Remuneration Committee (NRC), proposes the reappointment of **Mr. Rajvir Singh Chhillar** as an Independent Director for a second term of three years, from **December 27, 2024** to **December 26, 2027**.

In line with the provisions of Section 149 of the Companies Act, 2013 and SEBI LODR, the Board proposes his reappointment for a second term. The Nomination and Remuneration Committee (NRC), after reviewing his performance during the first term, has recommended his reappointment, acknowledging his leadership, strategic insights, and expertise in logistics, general management, and process optimization. Mr. Rajvir Singh Chhillar's contributions to operational efficiency, governance, and strategic decision-making have been crucial to the Company's growth and success.

The Board believes that Mr. Rajvir Singh Chhillar's reappointment will continue to bring immense value to the Company, given his extensive experience and track record. Therefore, the Board recommends his reappointment for a second term of **three years**, effective from **December 27, 2024** to **December 26, 2027**, with his office not subject to retirement by rotation, in accordance with the Articles of Association.

4. **Non-Debarment Declaration:** He has confirmed that he has not been debarred from holding the office of director by any regulatory authority.
5. **Ability to Discharge Duties:** He has confirmed that there are no circumstances or situations that could reasonably impair his ability to discharge his duties as an Independent Director.

6. **Transactions with Subsidiaries:** He has confirmed that he has not been a partner of any firm involved in transactions with the Company or its subsidiaries, amounting to **10% or more** of their gross turnover in the past three financial years.

The Board has thoroughly reviewed Mr. Rajvir Singh Chhillar's disclosures and confirms that he meets all conditions for reappointment under the Companies Act, 2013 and SEBI LODR, and continues to remain independent of the Company's management.
