Can't toss Trump's hush money conviction: Judge

AP NEW YORK

A judge Monday refused to throw out President-elect Donald Trump's hush money conviction because of the US Supreme Court's recent ruling on presidential immunity. But the overall future of the historic case remains unclear.

Manhattan Judge Juan M. Merchan's decision blocks one potential off-ramp from the case ahead of the former and future president's return to office next month. His lawyers have raised other arguments for dismissal, however. It's unclear when — or whether — a sentencing date might be set. Prosecutors have said there

should be some accommodation for Trump's upcoming presidency, but they insist the conviction should stand. A jury convicted Trump in May of 34 counts of falsifying business records related to a \$130,000 hush money payment to porn actor Stormy Daniels in 2016. Trump denies wrongdoing.
