Pursuant to Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015, we would like to inform you that the Company has utilized Proceedings of IPO and constructed new building for set up of plant and installation of new machineries for enhancement of existing installed production capacity from 1300 ton per month to 1420 ton per month. The said new machineries will be used for manufacturing of PET Bottles for Pharmaceutical applications, Liquor applications, FMCG Packaging, House Hold applications etc.

Further it is a great pleasure to inform that the Company has received all the requisite permissions from Government departments to start the production of PET Bottles except State Electricity Board, which will be received soon.

Further the Company is utilizing approx. 70-75% of production capacity currently and trying to increase the same by expansion of distribution network and approaching more clients in B2B and B2C for additional business.
