Referring to our earlier disclosure for the order passed by District Consumer Disputes Redressal Commission- IX (East District), Convenient Shopping Centre, Saini Enclave, Delhi-110092 against 'The New India Insurance Co. Ltd.' in matter of insurance claim on April 04, 2024 and in favor of Sheela Foam Limited awarding compensation amounting to Rs. 21,38,77,055/- along with an interest rate of 10% from the date of rejection in addition of Rs. 7,50,000 for mental anguish and losses, and Rs. 2,50,000 for legal expenses.

The New India Insurance Co. Ltd. has filed an appeal on June 21, 2024 before Delhi State Consumer Disputes Redressal Commission and on hearing the matter was dismissed on the ground that appellant has failed to give any acceptable and sufficient reasons to condone such delay.
