The crime against women seem to be increasing at an alarming rate. Crime is endemic to the human condition, but a crime specifically directed at one sex is most despicable and

unfortunately, the one that is punished least. It is found that the media exposure and all the legislation have little impact. Legislation introduced by the government is often merely tokenism. One would find that the problem before the majority of women in our country is not equality but survival. There is scarcely a day when cases of rape or a dowry murder are not reported from different parts of the country.

The pati-parneshwar has rudely and gradually been brought down to earth. The scenario for women seems grim indeed and this will continue so long as the basic social and economic structures remain unchanged and the implementing and law and order agencies show indifference. The thinking of society has to change and parents must value their daughters on a par with their

sons and should give them the same advantages and means of independence.

The law which is implemented for this purpose must also demonstrate that it will come down with a heavy hand on offenders otherwise we can put an to this problem. If the stories of rape and torture of women in India that have hit the headlines recently are anything to go by, then can we consider India to be a developing country? Among the worst countries in crime, India has an abhorrent track record in all forms of sexual exploitation. In homes, on streets, in public transports, at offices, even on vacations. No place is safe. And the most terrible fall out of this is the lack of self worth and feeling of degradation following the emotional and physical trauma that constant harassment creates. Such is the recurrence of these incidents that Delhi has earned the ignoble nickname of the 'Rape Capital'. While most cases go unreported as it is

considered an act that puts one to shame, only 20% of the registered cases for sexual harassment reach actual conviction.

The thinking of society has to change and parents must value their daughters on a par with their sons and should give them the same advantages and means of independence. It is rightly pointed out that "The subject of gender based violence, especially against women is complex, multilayered." The crime is an endemic to the human condition, but a crime specifically directed at one sex is most despicable and unfortunately, the one that is punished least. One would find that the problem before the majority of women in our country is not equality but survival. There is scarcely a day when cases of rape or a dowry murder

are not reported from different parts of the country.

Despite the existing legislation to protect women's rights women hesitate to take any step because of their own weak social and economics status. The movement for improving women's status should form part of the struggle against all inequalities and indignities prevalent in society. Yet, such are the vagaries of political existence — not least after the parliamentary election of 2024 — that the tributes to the man who was berated as the 'accidental prime minister' were invariably laced with sideswipes at Prime Minister Narendra Modi. It is as if Singh lacked any independent standing. His scholarship was contrasted with Modi's earthiness; his self-effacing humility with the present incumbent's flamboyance; and his political tentativeness with the present prime minister's certitudes. I don't think the implied comparisons with Modi enhanced Singh's stature. They were two very different individuals, with different personalities and temperaments, who had risen to the top of the political pile through divergent routes.

In a WhatsApp group comprising the alumni of one of Delhi's elite colleges, many of whose members had a good innings as senior bureaucrats under different Congress governments, there were many tributes to Singh and anecdotes about him, all pointing to the post-2014 sense of loss. Whether Singh inherently believed in reform by stealth or was forced into it by political compulsions, which included belonging to a party that was instinctively wary of market economics, is worth considering. In any case, economists as a tribe have always nurtured the conviction that managing the economy is a technical skill

that shouldn't be left to politicians, especially those who cut their teeth in mass mobilisation. Professional politicians, on the other hand, have felt that the economy is too important a sphere to be left to economists. To some extent, the liberalisation of the economy that P.V. Narasimha Rao and Singh kick-started in 1991 had to be disguised as either the result of a crisis of confidence (including pressure from the International Monetary Fund) or as the highest point of Nehruvian wisdom. It is doubtful if intelligent members of the Congress Party bought the latter justification but the ideological heresy at least allowed Singh to go about his business without having to answer insolent sceptics. Like many others, Singh underestimated the instinctive support of a very large body of Indians to the liberation from the licence-permit-control raj.
