This is with reference to the various announcement(s) submitted by the Company dated July 29, 2023, September 01, 2023, September 28, 2023, September 30, 2023, January 01, 2024, September 03, 2024, September 04, 2024 w.r.t. Loss of Share Certificate of the Company. In the said announcement, it was observed that the Company has quoted Aadhar Number and PAN of the Shareholders.

The consequential effect on account of the disclosure submitted by the Company, resulted into violation of Exchange communications and circular no. NSE/CML/2022/60 dated December 19, 2022, advising the Company for not disclosing PAN and Aadhar number/Aadhar related information in any disclosure/announcements/ any other public document made/submitted to the Exchange.
