Ratnagiri Maharashtra, India.

The fire was successfully contained within a minimal timeframe by the safety and emergency response team, resulting in minimal impact on plant and machinery. Fortunately, no human injuries or casualties have been reported. We are taking all necessary steps to address the situation and aim to resume normal operations at the plant as soon as possible.
