- 3. Notice: The notice dated August 06, 2024 was sent to the shareholders whose email addresses are registered with the Company / Depositories.
- 4. Cut-off Date: The Company had fixed the "Cut-off Date" for the purpose of deciding the entitlement of Shareholders / Members for remote e-voting during postal Ballot as September 06, 2024.
- 5. Remote E-voting Period: The remote e-voting platform was opened from Wednesday, September 18, 2024 at 9:00 a.m. (IST) till 5:00 p.m. (IST) on Thursday, October 17, 2024.
- 6. The Equity Shareholders of the Company holding shares as on September 06, 2024, the "Cutoff" date, were entitled to vote on the resolutions stated in the Postal Ballot Notice of the Company.
- 7. After closure of e-voting on Thursday, October 17, 2024, the votes cast were unblocked and downloaded from the e-voting website of Link Intime in the presence of two witnesses, Ms. Prajakta Pawshe and Ms. Vaibhavi Ladda, who are not in the employment of the Company. The e-voting results downloaded from the e-voting system of Link Intime were scrutinized and reviewed, the votes were counted, and the results were prepared.
