## Gist of Proceedings of the 40th Annual General Meeting (AGM) of the Company

### 1. Date, time and mode of the AGM:

The 40<sup>th</sup> AGM of the Company was held on Wednesday, September 25, 2024, through VC / OAVM. The Meeting commenced at 11:30 AM and concluded at 12:22 PM.

## 2. Proceedings in brief:

- Mr. Bo Jingen, Managing Director, chaired the Meeting.
- All Directors, Chief Executive Officer, Chief Financial Officer, Company Secretary, Statutory Auditor, Secretarial Auditor and the Scrutinizer participated in the AGM.
- The requisite quorum being present, the Company Secretary, with the permission of the Chair called the Meeting to order.
- The members were informed that the Meeting was held through VC / OAVM in compliance with the circulars issued by the MCA and SEBI.
- The Chairman addressed the members.
- ◆ AGM Notice was taken as read. Members were further informed that as there are no qualifications, adverse observations or comments or remarks or matters in the Independent Auditor's Report and Secretarial Audit Report for the year ended 31st March 2024, it was not required to be read.
- The Company Secretary informed that remote e-voting commenced at 9:00 A.M. on Sunday, September 22, 2024, and concluded at 5:00 P.M. on Tuesday, September 24, 2024.
- ◆ The Company Secretary also informed the members that Ms. Shaswati Vaishnav, Practising Company Secretary, (Membership No. A11392) M/s.Vaishnav Associates, was appointed as the scrutiniser to scrutinise the voting through electronic means (i.e. remote e-voting and voting at the Meeting through electronic voting system).
