## **GMR Airports Infrastructure Limited**

**Performance continues to trend upwards at GMR Airports**

**Delhi & Hyderabad Airports Pax Traffic in Q1FY25 continues to achieve new highs**

- **Delhi Airport - Reached 19.3mn Pax**
- **Hyderabad Airport - Reached 6.8mn Pax**

**Total Pax Traffic increased by 7% YoY to 31.8mn in Q1FY25**

**Total Income increased by 19% YoY to INR 2,522 Crs in Q1FY25**

**EBITDA increased by 18% YoY to INR 1,016 Crs in Q1FY25**

## **Key Developments**

### ***Completion of Merger of GMR Airports Ltd (GAL) with GMR Airports Infrastructure Ltd (GIL)***<sup>1</sup>

With an objective to enhance shareholder value by simplifying the corporate structure and bringing public shareholders closer to the airport assets, GMR had announced the execution of the Agreement and Scheme of Merger of GAL with GIL in Mar'23. This merger concluded in Jul'24. Corporate structure of GIL is further streamlined, and airport assets move closer to GIL shareholders. The enhanced corporate governance with an expanded board and a strong balance sheet has enabled GIL to be future ready. GMR Promoters continue to remain as the single largest shareholders and retain management control over GIL.

### ***"GIL Platform" being developed to foray into Airport adjacency businesses***

- **Hyderabad Airport:**
  - **Retail Master Concession:** All outlets novated to GIL by Airport. Letter of Intent issued to some luxury brands for Domestic terminal 'luxury zone'
  - **Car Park:** GIL has been awarded the contract and concession agreement has been signed. Business operationalized from 1 Aug'24
  - **F&B:** GMR Hospitality Limited (GHL) opened 5 outlets in Q1FY25 and is expected to open more than 30 outlets by Q2FY25
- **Mopa (Goa) Airport:**
  - **Duty Free:** Further strengthened the product portfolio by introducing watches and cosmetics categories. Rolling tobacco also introduced at the arrival store
  - **Car Park:** Parking Management System installed and operationalized in Jul'24

### ***Tariff Submission for Delhi Airport***

Delhi Airport submitted Tariff Proposal for 4<sup>th</sup> Control Period (1 Apr'24 to 31 Mar'29) in Q1FY25. In the interim period, AERA<sup>2</sup> has allowed Delhi Airport to extend existing tariff for further 6 months or till determination of CP4 tariff whichever is earlier.

### ***Delhi Airport Terminal 1 Update***

All flights have been moved to T2 and T3 immediately post the incident with no material impact on passenger traffic. Staff at T1 has been deployed to T2 and T3 to ensure smooth operations. Further, DIAL has enhanced capacity through additional X-Ray machines and doubled manpower at Call Centers to address queries. T2 and T3 have sufficient passenger facilities including F&B, Lounges, Retail, etc., to cater to the increased passenger traffic and the Airport is working closely with concessionaires to ensure business does not get impacted.

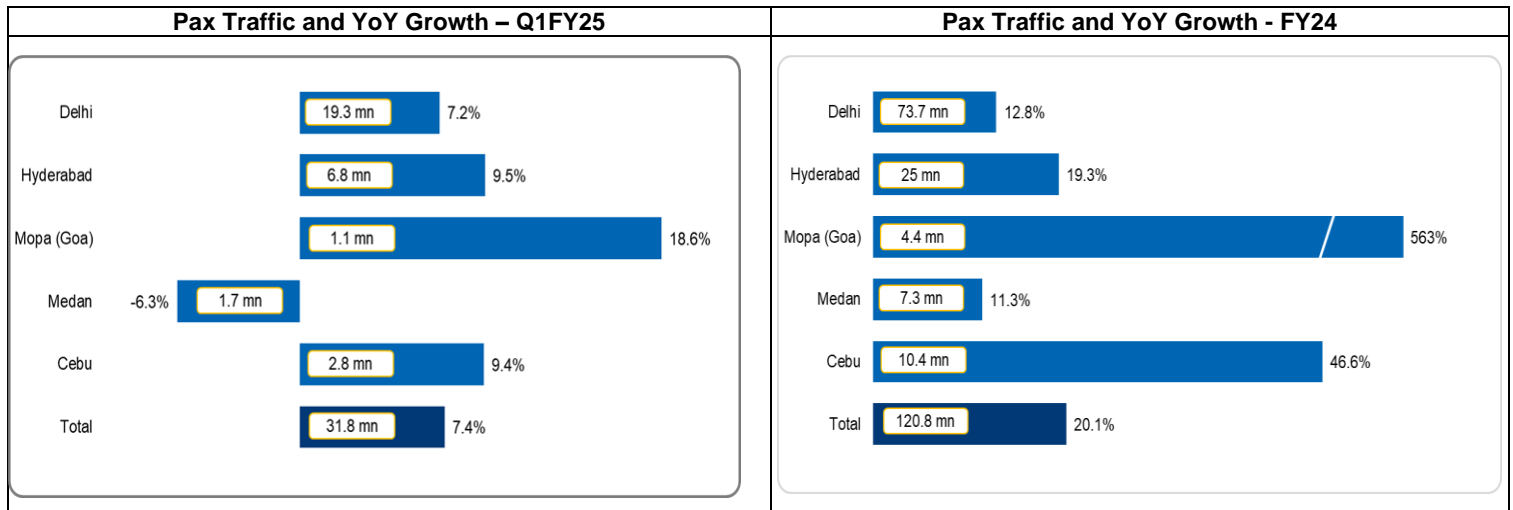

## Q1FY25 Performance Highlights

#### Delhi Airport



- **Traffic Insight** – Q1FY25: Pax traffic increased to 19.3mn, up by 7.2% YoY from 18.0mn in Q1FY24
  - Domestic traffic increased by 4.2% YoY while International traffic increased substantially by 16.6% YoY in Q1FY25
  - Witnessed highest ever quarterly traffic in Q1FY25
- **Key Financials** – Q1FY25: Total Income increased to INR 1,288 Crs up by 7.5% YoY from INR 1,199 Crs in Q1FY24.
- **EBITDA** increased to INR 392 Crs in Q1FY25 up by 3.8% YoY from INR 378 Crs in Q1FY24.
- **Submitted Tariff Proposal** for 4th Control Period (1 Apr'24 to 31 Mar'29) in Q1FY25

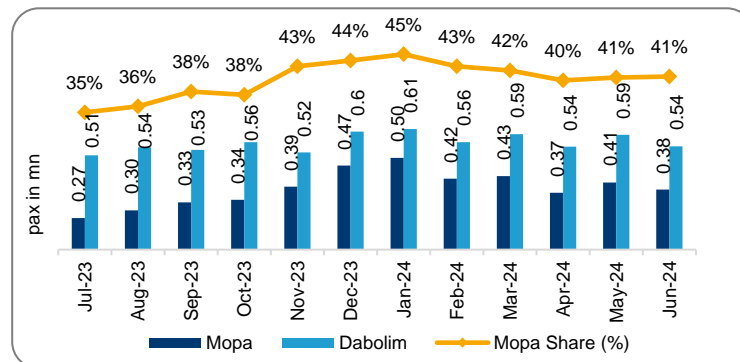

### Mopa (Goa) Airport

- Traffic Insight** – Q1FY25: Pax traffic increased to 1.15mn, up by 18.6% YoY from 0.97mn in Q1FY24
- Key Financials** – Q1FY25: Total Income increased to INR 95 Crs, up by 121% YoY from INR 43 Crs in Q1FY24.

- Physical progress of 29.7% achieved by Jun'24



**International Airports****Medan Airport (Indonesia)**

- Started operating the Airport from July 7, 2022
- Traffic Insight** – Q1FY25: Pax traffic at 1.71mn; down 6.3% YoY on account of supply side constraints
- Key Financials** – Q1FY25: Total Income stands at INR 123 Crs up by 4.8% from INR 118 Crs in Q1FY24. Non-aero revenues in Q1FY25 increased by 55.3% as compared with Q1FY24.
- EBITDA** decreased to INR 21.6 Crs in Q1FY25 down by 14.8% from INR 25.4 Crs in Q1FY25.
- Destinations connected** – 16 Domestic and 6 International destinations connected

**Crete Airport (Greece)**

- Project is fully funded mainly through State Grant (which is already received) and Airport Modernisation & Development Tax. It is a debt free project
- Overall progress of ~36% achieved as of 30 Jun'24
- Structural Concreting works of Passenger Terminal Building to be completed by Oct'24 and total project construction completion by Feb'27

**Cebu Airport (Philippines) – Equity divestment underway; to operate as Technical Services Provider till Dec'26**

- Traffic Insight** – Q1FY25: Pax traffic increased to 2.84mn, up by 9.4% YoY from 2.60mn in Q1FY24. On a QoQ basis, traffic increased 5.7% in Q1FY25
