



પર બાંધવામાં આવેલા પુલમાં કરવામાં આવ્યો હોવાનું ચર્ચાઈ રહ્યું છે.

મલાડમાં બાંધવામાં આવી રહેલા આ પુલ બાબતે પાલિકાના ઉચ્ચ અધિકારીએ જણાવ્યું હતું કે આ પુલ હજી નિર્માણધીન છે. એક વખત

પુલનું બાંધકામ પૂરું થઈ ગયું તો ત્યારબાદ તેને વર્તમાન સ્થિતિથી નીચે લાવવામાં આવશે. હાલમાં કામ કરવા માટે સ્ટક્ચરને વુડન લોગ પર મૂકવામાં આવ્યું છે. એક વખત ગર્ડર લોન્ચ થઈ જશે પછી મેટ્રોથી પુલ વચ્ચેનું અંતર ૩.૫ મીટરનું રહેશે. આ પુલ માત્ર હલકાં વાહનો માટે બનાવવામાં આવ્યો છે. પુલનું બાંધકામ પૂર્દુ થયા બાદ અહીં ઊંચાં વાહનો પર પ્રતિબંધ રહેશે અને તે માટે હાઈટ બેરિચર્સ બેસાડવાનું પ્રસ્તાવિત છે.

આ પુલનું કામ તેના અંતિમ તબક્કામાં હોવાનું માનવામાં આવે છે. આગામી બે મહિનામાં તેનું કામ પૂરું થાય એવી શક્યતા છે.

લગભગ ૪૫ કરોડ રૂપિયાના ખર્ચે આ પુલ બની રહ્યો છે. આ પુલ ૮૦૦ મીટરનો છે અને તે 'ટી-આકાર'નો છે. પુલની જમણી બાજુ ગિરિધર પાર્ક બ્રિજથી નીકળશે અને મલાડ્ ક્રીક ઉપરથી પસાર થશે. તો પુલની પશ્ચિમ બાજુ સેન્ટ જોસેફ સ્કૂલથી નીકળશે અને આગળ મલાડ સ્ટેશન અને વેસ્ટર્ન એક્સપ્રેસ હાઈવે તરફ જશે.
