#### **TO REVIEW THE REQUESTS RECEIVED FROM PROMOTER SHAREHOLDERS FOR RECLASSIFICATION FROM PROMOTERS TO PUBLIC CATEGORY**

The Board was informed that Dr. Vyasmurti Madhavrao Shingatgeri and Mr. Pradeep Chowdary Veeramachineni, Promoters had each, vide their respective letters dated 19.07.2024 requested the Company for re-classification from the 'promoter and promoter group' category to 'public' category shareholder of the Company.

The letters received from them were placed before the Board for its perusal.






