In this regard, we would like to provide the details of developments in relation to an ongoing litigation of Dalmia Cement (Bharat) Limited ("**DCBL**"), wholly owned subsidiary of the Company.

1.	The details of any change in the status and /or any development in relation to such proceedings;	As intimated earlier, the Company had filed Writ Petition before the Hon'ble Calcutta High Court ('High Court') for (i) grant of incentives amounting to Rs. 217 Cr. and; (ii) direction for granting VAT certificate of Rs. 20 Cr. along with subsequent disbursal.
		The Hon'ble Single Judge of High Court of Calcutta vide June 27, 2023 passed a judgement and order stating that entire amount of the incentive is to be disbursed by West Bengal State Industrial Development Corporation Limited (WBSIDC) in 3 installments together with interest @8% between the period of July and September, 2023.
		The impugned judgment / order dated June 27, 2023, of the Single Judge was challenged by the WBSIDC and the Industries Department by filing Writ Appeals before the Division Bench of the Calcutta High Court seeking reversal of the Single Judge judgment/ order including stay during the pendency of Writ Appeals.
		The Writ Appeals were listed for hearing on April 3, 2024 and the Division Bench of Calcutta High Court dismissed the Writ Appeals filed by WBSIDC. The Hon'ble Court has observed that it will be well open to the State to seek review of the Single Judge's order, if so advised.
		DCBL filed a contempt petition against WBSIDC before the Hon'ble High Court of Calcutta. Subsequently, WBIDC and the State of West Bengal filed review petitions seeking review of the order dated June 27, 2023. The Hon'ble Court directed listing of review petitions and the contempt petition together.
		The above matters were listed for hearing yesterday, i.e., 27.09.2024. The Hon'ble Court after hearing WBSIDC and the State dismissed the review petitions filed by WBIDC and the State of West Bengal and directed WBSIDC to ensure compliance with the direction of the earlier Court order dated June 27, 2023 and submit its report by November 8, 2024.
