**Subject: - Intimation of closure of Trading Window**

The date of Board Meeting to approve the Un-audited Standalone and Consolidated Financial Results for the 2<sup>nd</sup> Quarter and half-year ending on 30th September, 2024 shall be intimated to the Stock Exchanges in due course.

Further, with reference to SEBI Circular No. SEBI/HO/ISD/ISD-PoD-2/P/CIR/2023/124 dated July 19, 2023, regarding Trading Window closure period under Clause 4 of Schedule B read with Regulation 9 of SEBI (Prohibition of Insider Trading) Regulations, 2015 (“PIT Regulations”) – Framework for restricting trading by Designated Persons (“DPs”) by freezing PAN at security level, we have submitted our trading window closure to NSDL from 01.10.2024 till 16.11.2024 which is likely to be modified/changed after declaration of financial results.
