Dear Sir,

This is to bring to your attention that we, Dr. Agarwal's Health Care Limited ("AHCL"), a company registered under the provisions of the Companies Act, 1956 with CIN U85100TN2010PLC075403, are the promoters holding 71.90% shares of Dr. Agarwal's Eye Hospital Limited ("AEHL"), Scrip Code: 526783, whose shares are listed on the BSE Limited.

We had reported earlier on August 28, 2024, September 12, 2024, and September 21, 2024, that a pledge of over 11,63,59,500 Equity Shares of INR 1 each constituting 37.83% of equity shares of AHCL was created in favour of Catalyst Trusteeship Limited (Joint Trustee) to secure the financial facility for an amount of INR 2,15,00,00,000 (Indian Rupees Two Hundred and Fifteen Crores only) availed from JM Financial Credit Solutions Limited and INR 2,15,00,00,000 (Indian Rupees Two Hundred and Fifteen Crores only) availed from 360 ONE Prime Limited by the shareholders of AHCL. This has resulted in an *indirect* encumbrance over the securities of AEHL.

It is now submitted that out of the pledge created on 11,63,59,500 equity shares of AHCL, 6,36,49,872 Equity Shares has been *released* on September 25, 2024, by the Joint Trustee as per the terms of the facility availed by the shareholders.

Please find enclosed herewith the disclosure under Regulation 31(2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations 2011, for release of Indirect Pledge of equity shares.
