Subject: Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI LODR Regulations").

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**SEBI LODR Regulations**"), we wish to inform you that the Board of Directors at its meeting held today i.e. Saturday, October 19, 2024, has inter alia, approved the following:

Allotment of 1,58,34,000 No. of Equity shares on preferential basis

We would like to inform you that, pursuant to the special resolution passed on September 20, 2024 by the members of the Company in the 32nd Annual General Meeting and in pursuance of the In-principal approval Letter No. LOD/PREF/AM/FIP/1053/2024-25 dated October 04, 2024 of BSE Limited, the Board of Directors have approved the allotment of 1,58,34,000 (One Crore Fifty-Eight Lakhs Thirty-Four Thousand) no. of equity shares at a Face Value of Rs.10/- each at an issue price of Rs. 18/- each per equity share (including premium of Rs. 8/- per equity share) on preferential basis to the Promoters and Non-Promoters.

The Company has received the total consideration to Rs. 28,50,12,000/- (Rupees Twenty-Eight Crore Fifty Lakhs Twelve Thousand only) for allotment of 1,58,34,000 no. of equity shares as per the terms of the issue.

The new equity shares allotted, shall rank pari passu with the existing equity shares of the Company.

Post allotment of the aforesaid shares, the paid up capital of the Company has increased from Rs. 1,13,18,400 (11,31,840 equity shares of face value of Rs.10/- each fully paid up) to Rs. 16,96,58,400 (1,69,65,840 equity shares of face value of Rs.10/- each fully paid up).
