The Tamil Nadu Cabinet on Tuesday approved investment proposals worth ₹44,125 crore from 15 companies with Proposalsworth 744,125 crore from 15 companies with 24,700 job opportunities, spanning automobile manu-facturing, food processing and battery production, Finance Minister Thangam Then-narasu said.

Minister' Thangam Then-naraus said. Chief Minister MK Stalin chaired the meeting. He is leaving for an official trip to the US later this month to scout for investments. On Au-use 17 the Chief Minister will inaugurate the industrial housing facility for Foxcome employees at Stiperumbudur. The 18,220-bed facility was built at a cost of 22,05 crock, said Thennarasu.
