RTA claims that it did not receive requisite documents hence did not give effect to transmission. While Mr. Sood claims that he has submitted all requisite documents relating to transmission. Mr. Sood filed complaint before Commission, stating deficiency in service by RTA /Company to give effect to transmission.
