Sub: Allotment of Shares under Company Employee Stock Option Schemes
Ref: Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

The Stakeholders Relationship Committee of the Board of Directors of the Company at its Meeting held today, has approved an allotment of 75,806 equity shares of Rs.10/- each, being the exercise of 4,029 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013), 33,187 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014) and 38,590 equity stock options under the Employee Stock Option Scheme, 2022 (ESOS 2022). Out of 75,806 equity shares allotted in the meeting, 7,500 equity shares were allotted to Mr. A V Dharmakrishnan, Non-Executive Non-Independent Director and 13,750 equity shares were allotted to Mr. R Ravi Kula Chandran, Chief Financial Officer.

Consequent to this the paid-up equity share capital has increased from 3,54,88,864 equity shares of Rs.10/- each to 3,55,64,670 equity shares of Rs.10/- each. Kindly note that the Company has received the following in principle approvals from the Stock Exchanges in connection with the ESOS 2013, ESOS 2014 and ESOS 2022:

- i) The BSE Limited vide their letter No.DCS/IPO/CS/ESOP-IP/365/2014-15 dated 16th September, 2014 for ESOS 2013 and letter No.DCS/IPO/JS/ESOP-IP/465/2014-15 dated 30th October, 2014 for ESOS 2014 and letter No. DCS/IPO/TL/ESOP-IP/2477/2022-23 dated 05th September, 2022 for ESOS 2022.
- ii) The National Stock Exchange of India Limited vide their letter No.NSE/LIST/252668-7 dated 13th October, 2014 for ESOS 2013, letter No.NSE/LIST/252389-U dated 9th October, 2014 for ESOS 2014 and letter No. NSE/LIST/32266 dated 01st September, 2022 for ESOS 2022.

The Company shall apply for the listing and trading permission shortly.
