We wish to inform that based on the recommendation of the Audit Committee, the Board of Directors of the Company at its meeting held today 30th August, 2024 noted and accepted the decision of M/s. P.D. Saraf & Co., Chartered Accountants (FRN: 109241W) to discontinue as Statutory Auditor of the Company, vide its communication dated 30th August, 2024 (*Annexure I*). The Audit Committee considered the detailed reason provided by M/s. P.D. Saraf & Co., (outgoing/exiting Auditor) for discontinuing as the Statutory Auditors of the Company.
