You are requested to refer to your letter dated nil & 20.06.2024 vide which it is proposed to set up new project for Manufacturing of Ethanol Plant-75 KLPD at Gat No. 990(1), Beradwadi-Bhadgaon Tal. Gadhinglaj Dist. Kolhapur- 416 502 [a 'D+' Rest of Maharashtra zone] under the Package Scheme of Incentives (PSI) 2019 and Agro and Food Processing Policy, GR. No.PSI-2020/CR.80/Ind-8 dated 31.08.2020, wherein you have proposed to invest Rs. 113.72 Crores and provide employment upto 100 persons.

- I am happy to inform you that the Government of Maharashtra has decided to confer the status of "Large Scale Project" on your proposed project under Package Scheme of Incentive Policy 2019 and Agro and Food Processing Policy, GR No. PSI 2020/ CR.80/ Ind-8 dated 31.08.2020 on the basis of level of fixed capital investment and to offer the following incentives, subject to compliance of the conditions of the PSI-2019.
 - Electricity Duty exemption for a period of 10 years from the date of commencement of commercial production or Eligibility certificate.
 - 100% exemption from payment of Stamp Duty in accordance with the dispensation ii. in this regard under the Government Notification Revenue and Forest Department No. Mudrank-2019/UOR-No.23/ CR-328/ M-I dated 20/09/2019.
 - Industrial Promotion Subsidy (IPS) equivalent to 100% of eligible investments made within a period of 4 years from 1st January, 2024 or to the extent of 100% amount of taxes payable under the State Goods and Service Tax (SGST) within a period of 10 years, whichever is less.
 - This is subject to the condition that taxes under SGST are payable by the project in respect of first sale of finished products within state of Maharashtra eligible for incentives before adjustment of setoff or other credit available within a period of 10 years.
 - b. The amount of benefits availed at Sr. No. 2 (i) & 2 (ii) shall be deducted from the total eligible IPS amount.

3. It may be noted that-

- i. The IPS as a Large Scale Project will be admissible only after the company invests Rs.50 crore failing which, the project will not be treated as a Large Scale Project under food and agro processing policy but as a normal unit under PSI 2019, if otherwise eligible under that scheme.
- ii. The average annual amount of total incentives payable to the unit will be limited to total incentives divided by total period of availing of incentives.
- iii. The Company will determine the starting period of availing IPS within a period of 3 years from the date of commencement of commercial production in the project.
- iv. The amount of extra incentives over the average of concerned year will be admissible in the following next year.
- v. If the alcohol is used for liquor purpose then incentives will not be granted for such production.
- vi. The modalities for sanction and disbursement of industrial promotion subsidy under GST regime shall be as per G.R. Dt. 12.06.2018, 20.12.2018, 16.9.2019
- vii. The establishment should engage apprentices in a band of 2.5% to 15 % of total employment, as per the provisions of the Apprentices Act, 1961 (amended upto 2014) and the Apprenticeship Rules, 1992 (amended upto 2019).
- viii. The investment from 01.01.2024 to 31.12.2027 within 4 years period shall be eligible as fixed capital investment for Package scheme of incentive as per the Agro and Food Processing Policy, GR No. PSI 2020/ CR.80/ Ind-8 dated 31/8/2020.
- ix. The Categorization of secondary and Tertiary Level food processing unit shall be certified by Agriculture Department as per laid down norms. Also it shall be mandatory to procure raw material from farmer producer companies if primary processing of perishable goods is undertaken by your unit.
- 4. Kindly forward your application in the prescribed format to the Development Commissioner (Industries) for availing the above-mentioned benefits after completion of all effective steps along with the requisite documents as required under PSI-2019.
