Dear Sir / Madam,

Pursuant to Regulation 30 of the Listing Regulations read with Para-B, Part-A of Schedule III of SEBI Listing Regulations, we hereby informed you that fire occurred at Camex Limited. Leased Plant located at **PLOT NO. C-1/B, 7833 & 7834, NEAR DHIRAJ CAN CO., G.I.D.C., ANKLESHWAR, Gujarat-393002** on July 31, 2024, at around 10 am IST. The Plant manufactures PE Wax and make Export outside India and also Local Supplies to in India.

The fire was controlled, but production operation of the said plant is temporarily disrupted. There are no human injuries or casualties reported. Adequate steps are being undertaken to restore the operation of the plant. The Company is in the process of ascertaining the cause of the fire and the actual loss caused by it.

There is adequate insurance coverage for said plant and intimation to Insurance Company will be made in due course of time.
