Subject: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

Pursuant to Regulation 30 and Para A of Part A of Schedule III of the SEBI Listing Regulations we hereby inform that the National Stock Exchange of India Limited (“**NSE**”) vide their letter dated 13th December 2024, imposed a fine of Rs.5,000/- (Rupees Five Thousand only) for delay in disclosure of Related Party Transactions under Regulation 23(9) of SEBI Listing Regulations in XBRL Format.

The disclosure of Related Party Transactions under Regulation 23(9) of SEBI Listing Regulations for half year ended 30th September 2024 was submitted along with the financials of the Company on 24th October 2024 within 30 minutes of conclusion of Board Meeting. However, XBRL submission of the same was made on 25th October 2024 i.e. within 24 hours of conclusion of Board Meeting.
