Sir,

1. I, Mr.Shrinivas Mutta Devadiga, Practising Company Secretary have been appointed as the Scrutinizer by the Board of Directors of ICDS Limited pursuant to Sec 110 of the Companies Act and rule 22 of the Companies (Management and Administration) Rules, 2014 and Regulations 44 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015, to the extent applicable, for the purpose of scrutinising the e-voting as per the provisions of the Companies Act, 2013 on the resolutions contained in the notice dated November 12, 2024 issued by the Company.

In terms of section 110 of the Act and in terms of the circulars issued by the Ministry of Corporate Affairs, Government of India (the "MCA") vide its General Circular Nos. 14/2020 dated 8th April 2020, 17 /2020 dated 13th April 2020, 22/2020 dated 15th June, 2020, 33/2020 dated 28th September, 2020 and 39/2020 dated 31 December, 2020, 10/ 2021 dated June 23, 2021, 20/ 2021 dated December 8, 2021, 3/2022 dated May 5, 2022 and 11/2022 dated December 28, 2022 (the "MCA Circulars"), Company can take all the decisions requiring members' approval, other than items of ordinary business or business where any person has a right to be heard, through the mechanism of postal ballot/e-voting in accordance with the provisions of the Act and rules made thereunder, without holding a general meeting.

3. As a Scrutinizer of the process, my responsibility was restricted to ensure the process to be carried on in fair and transparent manner and report on the votes casted in 'Favour' and 'Against' the resolutions based on the reports generated from the remote voting system provided by CDSL. act, 2013, rules thereon and the listing regulations relating to the e-voting process and the postal ballot process on the resolutions contained in the notice dated November 12, 2024.

4. A public notice in newspaper informing the members about dispatch of notice and commencement of postal ballot was published on Friday, November 15, 2024. Members have been informed that those shareholders who were members of the Company as on cut-off date, i.e. Friday, November 15, 2024, and who have not, received notice of postal ballot and postal ballot form can request for a duplicate copy of postal ballot notice, if so required, and the postal ballot notice and postal ballot form can be downloaded from the website of the Company or website of CDSL.

5. I submit my report as under:

The dispatch of the Postal Ballot Notice dated November 12, 2024 was completed on November 15, 2024 to the Members whose names appeared on the Register of Members/ List of Beneficial Owners as received from Central Depository Services (India) Limited (CDSL) as on Friday, November 15, 2024. The Postal Ballot Notice was sent to the Members in electronic form to the email addresses registered with their Depository Participants (in case of electronic shareholding)/the Company's Registrar and Share Transfer Agents (in case of physical shareholding). In compliance with the requirements of the MCA Circulars hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope were not sent to the shareholders for this Postal Ballot and shareholders were requested to communicate their assent or dissent through the remote e-voting system only.

- 5.1 Particulars of all the postal ballot forms received from the members and votes cast through electronic means have been entered in the register separately maintained for the purpose.
- 5.2 The votes cast through electronic means were unblocked on December 20, 2024 at 6.23 P.M.
- 5.3 The votes cast through electronic means were scrutinized and the shareholding was matched/confirmed with the Register of Members of the company / list of beneficiaries as on Friday, November 15, 2024 (Cut-off date).
- 5.4 All votes cast through electronic means received up to 5.00 pm (IST) on December 20, 2024 being the last time and date fixed by the company for votes cast through electronic means were considered for my scrutiny.
- 5.5 The remote e-voting was unblocked in the presence of two witnesses who are not in the employment of the Company.
