Protest against potholes in bhiwandi, Parshuram overturned and fell into the pit in outrage



Bhiwandi, Anjali Swami:

These days, traveling on most of the roads in Bhiwandi Municipal Corporation area is inviting an accident. Due to the torrential rains that have continued for the last 15 days, potholes have formed at many places on the road. In such a situation, passing through here is not free from danger. A pothole on the road or a road in a pothole. The possibility of an accident increases when these potholes get filled with rain water and it becomes difficult to estimate the depth of the pothole. If you are in Bhiwandi city then walk with caution. Here, accidents are invited at every turn. Actually, there are no potholes on the roads here, rather there are roads in the potholes. School children held classes on the road and protested demanding repair of potholes on the roads. Citizens, children and women formed a human chain and registered a protest against the municipal administration at Old Thane Road, DargahDiwan Shah Complex. MPs, MLAs and party officials met Municipal Commissioner Ajay Vaidya and demanded to get the roads repaired. But all the movements and demands are neglecting. In fact, after a little more rain, roads in many areas of the city were completely flooded with water through drains. The administration hastily installed paver blocks on the roads. But in the rain the paver block itself became the enemy. Motorcycle and auto drivers got stuck in this paver block and started getting injured. Bhiwandi General Secretary of Anti-Corruption Committee, Parshuram Palat, had given a request letter to the Pala Municipal Commissioner demanding repairs of the roads and when the demand was not met, they protested by worshipping the pits, breaking coconuts and rolling in the pits. Was warned to demonstrate. Today, along with his colleagues, he performed puja by breaking coconuts in the potholes of the roads and protested by rolling upside down in the same potholes. Whose video is going viral on social media. Parashuram Pal is the same person who had himself entered the drains with a shovel when the drains were not cleaned and had tried to commit suicide in front of the Municipal Corporation headquarters when the drains were not cleaned properly.

Bhiwandi, Anjali Swami:

Most of the roads in Bhiwandi city of Thane district, home of state Chief Minister Eknath Shinde, have become impassable in this rain. Due to lack of control on big vehicles by the traffic department, vehicles are entering the city limits despite being a prohibited area, due to which there is huge jam on the highways, bypasses and main roads of the city. The roads have been completely damaged due to the movement of these vehicles. Due to heavy rains, there are big potholes on the roads. The convoy of Chief Minister Eknath Shinde, who came on the Bhiwandi tour, had to hesitate in these potholes. Due to which CM Shinde himself had to face the reality of pothole free roads. CM Eknath Shinde had reached Bhiwanditaluka on a one-day visit to inspect the potholes on the Mumbai Nashik Highway. CM's convoy along with LavLashkar had reached AnjurPhata via Rajnoli Naka, Sai Baba Temple, LateBala Saheb Thackeray Flying Bridge- Dhamankar Naka Flying Bridge. Municipal officials were shocked by the sudden entry of CM Eknath Shinde's convoy in Bhiwandi city. This convoy left Thane via Anjurphata, Purna, Kalher, Ksheli. After seeing the reality of the city firsthand, the citizens have hoped from CM Shinde that the face and condition of the city will improve soon.

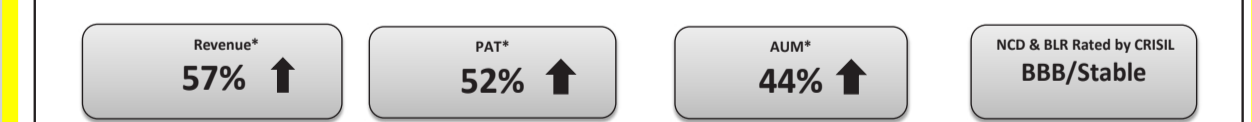
