

Political Game: Mahayuti vs Maha Vikas Aghadi in Maharashtra

The political battlefield in Maharashtra is heating up, with the BJP-led Mahayuti taking on the Congress-led Maha Vikas Aghadi (MVA) in what promises to be a fierce contest. After the splintering of the Shiv Sena and the NCP, the stakes have become even higher, with multiple layers of strategy and intrigue at play. What adds to the complexity is that neither of the two major alliances has yet named a chief ministerial candidate.

While the primary battle grabs the headlines, there are also significant internal skirmishes unfolding within both camps. Within the MVA, the Congress, the NCP (Shradh Pawar faction), and the Uddhav Thackeray-led Shiv Sena (UBT) have been locked in intense negotiations over seat-sharing. Each party is determined to secure a larger share of the pie, with talks often veering into high-stakes negotiations.

After prolonged deliberations, the alliance has reportedly settled on a compromise formula: 85 seats each for the Congress, NCP, and Shiv Sena, out of the 255 constituencies they plan to contest. The remaining seats will be allocated to smaller allies like the Samajwadi Party, AAP, and Left parties. The key takeaway is that Congress and Uddhav's Shiv Sena have backed down from their initial ambitions, agreeing to contest fewer than 100 seats each. This concession has helped break the deadlock just ahead of the nomination deadline, potentially giving the MVA the momentum it needs to challenge the ruling Mahayuti alliance.

However, the Congress, which had gained significant ground in Maharashtra during the 2024 Lok Sabha elections, has seen its bargaining power erode after its unexpected defeat in Haryana. The MVA, which had



swept 31 of Maharashtra's 48 Lok Sabha seats earlier this year, has learned the hard way that overconfidence can be a dangerous game, especially when facing an opponent like the BJP, adept at managing factionalism and rebellion within its ranks.

The MVA's partners now recognize the urgency of putting aside their differences and presenting a united front in the Assembly elections.

On the other side, the BJP, despite being the senior partner in Mahayuti, has allowed the Shinde faction to hold the CM's chair. The saffron party is banking on its "kingmaker" strategy, leveraging its influence over the alliance, particularly over Ajit Pawar's NCP, which is seen as the weakest link. Having played a pivotal role in the splits within both the Shiv Sena and the NCP, the BJP's primary challenge now is to keep its coalition intact and avoid any cracks that could derail its bid for power.

As the battle lines are drawn, the focus shifts to how these alliances will navigate their internal divisions and whether they can present a coherent challenge to the BJP's well-oiled political machine in Maharashtra. The coming weeks promise to be crucial in shaping the state's political future.
