EbixCash has successfully begun the rollout of a Comprehensive Ticketing Solution for the Karnataka State Road Transport Corporation (KSRTC).

The Transport Division of EbixCash has been chosen by KSRTC as the Technology Solution Provider for the supply, commissioning, and maintenance of **Smart Electronic Ticketing Machines (ETMs)** as part of a comprehensive ticketing solution. **This five-year contract, valued at approximately INR 335 Million**, covers all state-run buses.
