Berlin, Nov 11 (IANS) : German Chancellor Olaf Scholz said Germany will continue its commitment to strengthening defence forces in the coming years, including modernising the Bundeswehr with a special fund of 100 billion euros (\$108 billion). Noting that Germany has reached the target of spending 2 per cent of its economic output on defence for the first time this year.
