DANG BUS MISHAP

50-year-old woman succumbs to injuries, accident toll rises to 6

MLA to meet authorities today with request to widen the roads

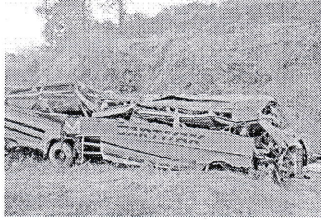
WITH A 50-year-old woman succumbing to her injuries on Monday, the death toll in the Dang district accident, in which a luxury bus carrying pilgrims from Madhya Pradesh fell into a gorge early Sunday, reached six, officials said.

The deceased has been identified as Shantiben Bogha, who belongs to MP's Shivpuri district as the five other victims. She breathed her last at the Surat CWH Hospital. An FIR was lodged against the driver, Katanlal Jaiswal, who also died in the accident, for rash and negligent driving.

Meanwhile, the local BJP MLA and Deputy Chief Whip of Gujarat State Legislative Assembly, Vijay Patel, told The Indian Express that he will make a representation to officials in Gandhinagar on Tuesday, requesting them "to widen the roads and make corrections in the sharp curve to prevent such regular accidents of cars."

The bus, carrying over 20 passengers from Trimbakeshwar in Nashik in Maharashtra to Dwarika in Gujarat, plunged into a 25-foot-deep gorge after breaching the protection wall near the Forest Department rest house at Malegaon near Sapantia in Dang — the entry district to Gujarat for people coming down from Nashik — at 4:30 am on Sunday. Besides Bogha and Jaiswal, the other four deceased were Bholaram Kushwaha (55), Guddi Yadav (60), Bijendra Yadav (55), and Kamlesh Yadav (60). Over 24 passengers were severely injured in the accident.

One of the survivors, Brijesh Bhargav, lodged a complaint against the driver under sections pertaining to negligence, among others. Bhargav alleged that the driver lost control over the steering wheel after which the bus plunged into the gorge.

Vijay Patel, the Bharatiya Janata Party (BJP) MLA from Dang, told The Indian Express, "Regular accidents take place in the 9-kilometre area from Malegaon downwards. The area falls under National Highways (NHAI), and we have been regularly making requests to them to widen the roads and make changes in the sharp curve areas. I will also make a representation to the state government and talk to higher officials of NHAI in Gandhinagar on Tuesday."

Narasari district Superintendent of Police Yashpal Jagana said, "There are sharp turns on narrow roads, which are accident-prone areas. We have also talked to the highway authorities... The accused bus driver could not see the sharp turn as a result of which the accident took place."

Devram Thackrey, the husband of Malegaon village sarpanch Tammanyben and one of the first responders in the accident, said, "The road climbing down (the Chat area) from Sapantia to Malegaon is quite narrow. Plus there are sharp curve turns as a result of which we regularly witness accidents of heavily loaded vehicles going from Nashik to Gujarat."

On the rescue operation, he said, "We are equipped with rescue equipment like two bamboo sticks holding up the corners of a bed sheet or blanket on which we carry the injured passengers. We also deploy vehicles and ropes to get deep into the gorge. After getting rescue calls, our team of 20 youths immediately reached the spot and carried out the rescue operations. Before police could arrive, we shifted 20 patients from the spot to nearby Shiangham PHC (Primary Health Centre)."

On the accident-prone nature of the terrain, he said, "We have complained to the district collector, police officials, political leaders, and others a number of times but nothing has been done."

Patel could not be contacted for his remarks over the row.

Slamming the BJP over Patel's statements, Congress spokesperson Manish Doshi said, "With this public statement (of Nitin Patel), BJP's face, conduct and character stand exposed. It has been the policy of the BJP to wear the party's scarf and in return take the licence to lose."

Doshi alleged that because of BJP's policy of letting people carry out loot and then asking them to deposit a part of it to Kamalaji (Gujarat BJP state headquarters) that Gujarat is witnessing scams repeatedly.

"The pain expressed by Ninihal Patel actually the story of BJP's corruption. It exposes BJP's face, conduct and character," Doshi added.

Gujarat BJP media convener Yagnesh Dave, however, said, "If you see the video, Ninihal is saying that in the name of BJP workers, people get government works done and become rich. So, they (such brokers who are not party workers) defame the party. In the name of the party, such brokers, who are not party workers, reach out to government officials in the name of the party."

AS LUGDEST has erupted over the recent purported remarks of former Deputy Chief Minister of Gujarat and senior BJP leader Nitin Patel about "politically witnessing 'dalals' (brokers) who have become millionaires through broking" with the opposition Congress alleging that his statements have "exposed" the ruling party once more.

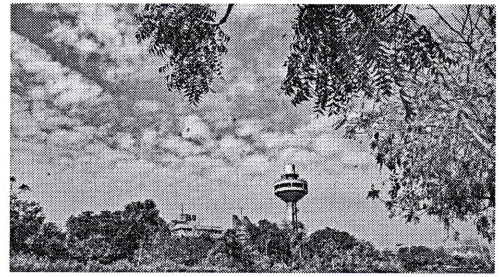
A purported video of remarks made by Patel — believed to be from a function in Mehsana district — has gone viral on social media platforms. Patel made these remarks while attending a function to celebrate 75 years of an educational institute in Daran village of Mehsana district's Kadi tehsil on Sunday.

In the video, which is believed to be part of Patel's speech on the occasion, the former Deputy CM is heard saying in Gujarati (*Hamara rajkaran nia yeh dalal bhadra thoi gup chhe. Dalal karu nodhedar chhu. Adhikar fatfat kam kari aape.*), roughly translated into English as, "Nowadays, people have become dalals (brokers) in politics too. Keeping acquaintances with government officers... doing broking (while claiming) I am BJP office bearer, a BJP worker, (or) leader. The government officer gets work done expeditiously."

Patel can also be heard saying (*Aa BJP sarkar e badha ne bahu sikh kariya. Ane dalal karta karta aage badha karodpat thoi gaya.*). "This BJP government has made all (every) one very happy. And (they) all have become millionaires while doing broking."

CHIEF MINISTER Bhupendra Patel Monday launched Sensex Futures & Options contracts at the India International Exchange (India INX), in Gandhinagar's GIFT City.

The Sensex F&O will now be available for investors globally and they can now invest directly in them using US dollars. A government statement, quoting the CM, said: "This will enable the global investors to trade in Indian markets." According to the statement, "With a 22-hour trading window, it aims to foster deeper integration of India's financial market with the global financial system."

Trading in derivatives at India INX, GIFT City, is advantageous for global investors as it has zero Securities Transaction Tax (STT), Stamp Duty, and GST, said sources.

"The launch of BSE Sensex derivatives at India INX represents a key step in broadening access to India's benchmark index for global investors. As one of the most recognized indices representing the Indian equity market, BSE Sensex derivatives will offer international investors an efficient avenue to participate in India's growth story," said the statement while quoting BSE MD & CEO Sundararaman Ramamurthy.
