- We have reviewed the accompanying statement of Unaudited Financial Results ("the Statement) of M/s Coral Newsprints Limited ("the company") for the quarter and half year ended 30th September 2024 being submitted by the company pursuant to the requirement of regulation 52 of the SEBI (Listing Obligations & disclosure requirements) Regulations, 2015, as amended, including relevant circulars issued by the SEBI from time to time.
- 2.
