Dear Sir,

- I, Mayank Kapoor, Advocate, Proprietor of M/s. MAYANK KAPOOR, New Delhi has been appointed by the board of Directors of Nam Securities Limited ("the Company") as the Scrutinizer for the purpose of Scrutinizing e-voting process and poll process in a fair and transparent manner and ascertaining the requisite majority on voting carried out as per the provisions of the Companies Act, 2103 read with Rule 20 of the (Management and Administration) Rules, 2014 in respect of the Resolutions passed at the 30th Annual General Meeting (AGM) of the Members of the Company, held on Monday, September 30, 2024.
- 2. It is the responsibility of the Management of the Company to ensure due compliance of the applicable provisions of the Companies Act, 2013 and Rules made there under and also the requirements thereof relating to voting through electronic means and Polling Process on the resolutions contained in the notice of 30th Annual General Meeting of the Members of the Company. As the Scrutinizer for the evoting process and poll process, my role and responsibility are limited to make a Scrutinizer's Consolidated Report of the votes cast "in favour" or "against" in respect of the Resolutions contained in the Notice of 30th AGM based on reports generated from the e-voting system provided by National Securities Depository Limited (NSDL) the authorized agency to provide Remote e-voting facilities, engaged by the Company and from the Polling Process conducted at the 30th AGM.
- 3. Further to above, I submit my Report as under:
 - i. The Remote e-voting period commenced from Friday, September 27, 2024 (10:00 A.M.) to Sunday, September 29, 2024 (05:00 P.M.)
 - ii. The Members of the Company as on the "cut-off" date i.e. Monday, September 23, 2024 were entitled to vote on the Resolutions (Item No. 1 to 32 as set out in the Notice of the 30th Annual General Meeting of the Company).

- iii. After the time fixed for closing of the poll by the chairman, I(one) ballot box kept for polling was locked in my presence with due identification marks placed by me.
- iv. The locked ballot box was subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company/Registrar and Transfer Agents of the Company and the authorizations/proxies lodged with the Company.
- v. The poll papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- vi. Thereafter, the electronic votes cast through remote e-voting were unblocked on Monday, September 30, 2024 after the AGM was over in the presence of 2(Two) witnesses Mr. Vimal and Mr. Ombir singh who are not in the employment of the Company.

It contained the particulars of name, address, folio number or client ID of the shareholders, number of shares held by them, nominal value of such shares. There were no shares with differential voting rights in the Company; hence there is no requirement of maintain of the list of shares with differential voting rights.
