Please note that the Company has received an order on August 29, 2024 at 08:18 p.m. from Joint Commissioner, CGST & Central Excise, Patna-I, raising a GST demand of ₹ 4,442/- and levying penalty of ₹ 20,000/- for FY2019-20 and GST demand of ₹ 33,18,413/- and levying penalty of ₹ 3,31,841/- for FY2020-21 under Section 73 of the Central Goods and Services Tax Act, 2017 (“the Act”). The Company would pursue an appeal with Appellate Authorities/ evaluate other legal options against the said Order.
