## Sub.: Response to Penalty Imposed for Non-Compliance with Regulation 6 of SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015

Dear Sir(s),

With reference to the captioned subject, we acknowledge the receipt of your communication dated November 21, 2024, regarding the imposition of a penalty of Rs. 16,520/- (including GST) against Asian Warehousing Limited (the Company) for non-compliance with Regulation 6 of SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015.

In response, we wish to inform you that, in adherence to the regulatory requirements, the fine amount of Rs. 16,520/- (including GST) has been paid by the Company on November 28, 2024.

The aforementioned non-compliance occurred due to the sudden resignation of Ms. Rashmi Agarwal (ex-Company Secretary and Compliance Officer) w.e.f. June 17, 2024, post which the Company made all possible efforts to fill the said vacancy, within the prescribed time as per Section 203(4) of Companies Act 2013. Considering the level of competency required for the said post, it took reasonable time to identify and finalize the potential candidate. The company has appointed Ms. Sony Pavanan (ACS 71657) as Company Secretary and Compliance Officer (Key Managerial Personnel) with effect from October 21, 2024.
