Re : Consolidated Report of Scrutinizer on passing of resolutions through Postal Ballot, vide Postal Ballot Notice dated January 15, 2025 only by way of remote E-voting of Adani Wilmar Limited (The "Company")

- The Board of Directors of the Company, by Resolution passed on January 15, 2025 has appointed us as Scrutinizer for conducting the postal ballot (e-voting process) for passing the resolution as set out in the Notice of Postal Ballot dated January 15, 2025.
- 2. In terms of the Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No.20/2020 dated May 5, 2020 , General Circular No.22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular No. 10/2021 dated June 23, 2021, General Circular No. 20/2021 dated December 8, 2021, General Circular No.3/2022 dated May 5, 2022, General Circular No 11/2022 dated December 28, 2022 and General Circular No 09/2023 dated September 25, 2023 and General Circular No. 09/2024 dated September 19, 2024 (collectively referred to as the "MCA Circulars") the Company had sent the postal ballot notice in electronic form only. The hard copy of the Postal Ballot Notice along with Postal Ballot forms and pre-paid business envelopes were not sent to the members for the postal ballot in accordance with the requirements specified under the MCA Circulars. Accordingly, the communication of the assent or dissent of the members would take place through the remote evoting system only. To facilitate such members to receive the postal ballot notice electronically and cast their vote electronically, the Company had made arrangement for registration of email addresses in terms of the MCA Circulars. The Notice had also been placed on website of the Company at https://www.adaniwilmar.com/ and e-voting website at www.linkintime.co.in. and also available on the website of stock exchange at www.bseindia.com and www.nseindia.com.



- 3. We submit our report as under:
- 4. The Notice of the Postal Ballot dated January 15, 2025, alongwith the statement under Section 102 of the Companies Act, 2013 setting out all material facts in respect of the resolutions mentioned therein was sent electronically by email to the members whose names appear in the register of members/ list of beneficial owners as received from National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on January 17, 2025 in compliance with the above referred MCA Circulars.
- 5. The Company completed the dispatch of Postal Ballot Notice by e-mail on January 23, 2025. In accordance with the MCA Circulars, no physical ballot notice was dispatched to the Members. The Company has also published Newspaper Advertisement in The Indian Express (English) and Financial Express (Gujarati) respectively, regarding the dispatch of Notice of Postal Ballot along with Remote E-voting Information and containing all the matters required under Companies Act, 2013 and relevant rules on January 24, 2025
- 6. The Company has offered E-voting through MUFG Intime India Private Limited (formerly known as Link Intime India Private Limited) and the report contains the details of E-voting only.
- 7. The facility of E-voting remained open from 09.00 a.m. on Saturday 25th January, 2025 and ended at 5.00 p.m. on Sunday, 23rd February, 2025.
- 8. We have unblocked the votes cast through remote E-voting in the presence of Mr. Raimeen Maradiya and Ms. Charmi Shah who are not in the employment of the Company. Thereafter, the details containing, inter-alia the list of members who voted "For" or "Against" the resolutions were derived from the report generated from the evoting website of MUFG Intime India Private Limited (formerly known as Link Intime India Private Limited) i.e. https://www.linkintime.co.in.

9. A Summary of postal ballot through E-voting is given below:

*Out of the aforesaid equity shareholders who voted for the resolution and against the resolution, respectively, 3 equity shareholder has partially voted for the resolution and partially against the resolution. Therefore, for the purpose of numbers the said 3 equity shareholder has been considered only once. Thus, 1850 equity shareholders in number (1664+189= 1853 - 3 = 1850) voted during the remote e-voting. ** 13 equity shareholder less voted by 57129 shares.

- 10. You may accordingly declare the results of the voting by postal ballot only by way of remote E-voting.
- 11. The Register, all other papers and relevant records relating to electronic voting shall remain in our safe custody until the Chairperson considers, approves and signs the Minutes of the aforesaid Resolutions passed by way of Postal Ballot and the same will be handed over to the Company Secretary of the Company for safe keeping.
