

In line with the General Circular of MCA, SEBI also came with Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated 7th October, 2023 to provide relaxation to listed entity from compliance with certain provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 till 30th September, 2024.

In compliance of the provisions of Companies Act, 2013 ("the Act"), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI Listing Regulations) and MCA General Circulars and SEBI Circulars, the 30th AGM of the Company is being held through VC/OAVM, without the physical presence of the members at a common venue. Deemed venue of the AGM shall be the Registered Office of the Company at Jindal Towers, Block B, 4th Floor, 21/1A/3, Darga Road, Kolkata – 700017.

Further, pursuant to the aforesaid Circulars, the Notice of the AGM along with the Annual Report for FY 2023-2024 is sent in electronic form only to those Members whose email addresses are registered with the Company/ Depositories. The Notice calling the 30th AGM has been uploaded on the website of the Company at https://www.rossellindia.com/investor-information/.

17. Dematerialization of the Equity Shares of the Company

The Equity Shares of the Company are compulsorily required to be held under DEMAT mode for Trading on the Stock Exchanges, where such Equity Shares are listed. These can be held in electronic form with any Depository Participant (DP) with whom the Members have their Depository Account. All the Members, holding Equity Shares of the Company in the physical form, are advised to get the same dematerialized. The Members may contact the Registrar and Share Transfer Agent of the Company at their address mentioned above in case of any query /difficulty in the matter or at the Registered Office of the Company.

SEBI vide its Circular no. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2022/8 dated January 25, 2022 has mandated the listed Companies to issue securities in dematerialized form only while processing service requests viz. Issue of duplicate securities certificate; claim from unclaimed suspense account; renewal/ exchange of securities certificate; endorsement; sub-division/splitting of securities certificate; consolidation of securities certificates/folios; transmission and transposition. Further SEBI vide its circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2022/65 dated May 18, 2022 has simplified the procedure and standardized the format of documents for transmission of securities. Accordingly, Members are requested to make service requests by submitting a prescribed and signed form as made available on the Company's website at https://www.rossellindia.com/investor-information/ and on the website of the Company's Registrar and Share Transfer Agents, CB Management Services Private Limited at www.cbmsl.com.

It may be noted that any service request can be processed only after the folio is KYC Compliant. In view of this and to eliminate all risks associated with physical shares and for ease of portfolio management, Members holding shares in physical form are requested to convert their holdings to dematerialized form. Members can contact the Company's Registrar and Share Transfer Agent for assistance in this regard.

- 18. SEBI vide Circular no. SEBI/HO/OIAE/OIAE_IAD-1/P/ CIR/2023/131 dated 31 July, 2023 (updated as on 20th December, 2023) has specified that a shareholder shall first take up his/her/their grievance with the listed entity by lodging a complaint directly with the concerned listed entity and if the grievance is not redressed satisfactorily, the shareholder may, in accordance with the SCORES guidelines, escalate the same through the SCORES Portal in accordance with the process laid out therein. Only after exhausting these options for resolution of the grievance, if the shareholder is not satisfied with the outcome, he/she/ they can initiate dispute resolution through the Online Dispute Resolution ("ODR") Portal. Shareholders are requested to take note of the same.
- **19.** Members are requested to send their queries, if any, on Annual Report to the Company Secretary, at least 7 days before the date of Meeting, so that the requisite information/explanations can be provided in time.

21. Voting through electronic means:

- 1. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 (as amended), and the Circulars issued by the Ministry of Corporate Affairs dated 8th April, 2020, 13th April, 2020, 5th May, 2020, 5th May, 2022 and 25th September, 2023 the Company is providing facility of remote e-Voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the authorized agency. The facility of casting votes by a member using remote e-Voting system as well as e-voting on the date of the AGM will be provided by NSDL.
- 2. Those Members who will be participating in the AGM through VC/OAVM facility and have not cast their vote on the resolutions through e-voting prior to AGM are otherwise not barred from doing so, shall be eligible to vote through e-voting system during the AGM.



- 3. The Members who have cast their vote by remote e-voting prior to the AGM may also attend and participate in the AGM through VC/OAVM means, but shall not be entitled to cast their e-vote again.
- 4. The Board of Directors has appointed Mr. Atul Kumar Labh, Practising Company Secretary (FCS-4848/CP-3238) of M/s. A. K. Labh & Co., Company Secretaries, Kolkata as the Scrutinizer for providing facility to the Members of the Company to scrutinize the e-voting process in a fair and transparent manner.
- 5. The Scrutinizer shall submit his report to the Executive Chairman of the Company or Director (Finance) and Company Secretary as authorised by the Board, after the completion of scrutiny of the votes cast through e-Voting. Share Capital

During the year under review, there has been no change in the Share Capital of the Company.

The Company has not issued any shares with differential voting rights, employee stock options and sweat Equity Shares.

Appropriation of Profit After Tax For Transfer To Reserves

During the Financial Year 2023-2024, an amount of ₹ 1,000 lakhs was separately transferred to General Reserve in terms of the first proviso to section 123(1) of the Companies Act, 2013 and a sum of ₹ 185.96 lakhs was kept as retained earnings.

Your Directors are pleased to recommend to the Members, for their approval, a Dividend of ₹ 0.30 per Equity Share of ₹ 2 each (i.e 15% on the paid up capital) (2023 - 20%) in the Company for the year ended 31st March, 2024.

The State Of Company's Affairs

Revenue

The gross revenue of your Company including sale of Tea, Black Pepper, Avionics Equipment as well as Receipt for Technical and Support Services have been higher by 3.67% at ₹ 36,657.70 lakhs as against ₹ 35,358.32 lakhs for the previous financial year 2022-2023.

Performance

Rossell Tea

While the Directors' were concerned with Rossell Tea Divisions below par performance for the financial year 2023-24 they are encouraged that it remains one of the best in the industry. Extreme weather conditions were experienced with low rainfall and increased pest activity which led to a significant drop in production. We were able to produce 46.60 lakh kgs own crop and 5.07 lakh kgs from bought leaf totaling to 51.67 lakh kgs. Despite adverse weather conditions, high quality Orthodox and CTC compliant teas were outturned.

CTC production was maximized as the price realization of this category was much higher than the Orthodox variety for which the demand remained muted with significantly lower prices.

The CTC prices which opened lower in the beginning of the year, moved up slightly in May and June due to the lower production in April/ May. Thereafter the CTC prices were lower till October with a slight uptick in November. Subsequently till the end of the season the prices kept dropping owing to overproduction and less demand & consumption.

The Orthodox market opened low initially due to over production. Prices kept falling till end January with a slight movement upward in Feb/March. The overall Orthodox prices were lower by ₹ 61.91 per kg for the industry. Orthodox production was curtailed to 19.97 lakh kilograms as compared to 30.58 lakh kilograms in the previous year. We produced 31.70 lakh kilograms of CTC tea as compared to 26.02 lakh kilograms in the previous year.

Our Orthodox sale averages are ₹ 254.24 per kg as against ₹ 301.65 per kg in the previous year and in the CTC category ₹ 287.56 per kg as against ₹ 284.03 per kg.

It is worthy to note, that in both the categories of tea our averages are significantly higher than the Industry averages for the Assam Valley which are ₹ 220.78 per kg for Orthodox and ₹ 213.09 per kg for CTC. Thereby making our realization for orthodox approximately 15% higher and CTC approximately 35% higher than the industry average for the Assam Valley.

Our sale average of ₹ 274.26 per kg for our teas is the 3rd highest ever achieved.

Our exports recorded an increase of 46% during the financial year, from 6.32 lakh kilograms in the previous year to 9.22 lakh kilograms. Overall exports out of India have been dropping in favour of the African teas which are much cheaper and logistically better located. Another factor which has contributed to the lower exports is the ongoing Ukraine/Russia conflict and the conflicts in West Africa which have led to high inflation and recession worldwide. In spite of these factors, your company's exports were significantly higher to the UK, UAE, and Germany in the financial year 2023-2024.

Our product-mix allowed us to realize the best possible value for our teas. Improved productivities and efficiency, helped to obviate the wage cost which was increased from 1st October 2023 to some extent but the costs went up due to the lower production.

The total income has reduced from ₹ 168.90 crores to ₹ 150.80 crores on the backdrop of lower production and lower Orthodox prices.

Rossell Techsys

Rossell Techsys has achieved a 16.37% growth in Operational Revenue in the Financial Year 2023-2024, from ₹ 186.37 Crores in Financial Year 2022-2023 to ₹ 216.88 Crores in Financial Year 2023-2024. The Operating profit (EBITDA) has grown by 13.62%, from ₹ 31.27 Crores in Financial Year 2022-2023 to ₹ 35.53 Crores in Financial Year 2023-2024. The PBT has also grown by 21.88%, from ₹ 12.02 Crores in Financial Year 2022-2023 to ₹ 14.65 Crores in Financial Year 2023-2024.

Rossell Techsys produced a total of 43,303 units in a single year, an increase of over 5,600 units from the previous year. The delivered goods have been a very high product mix, with varied complexities, and low volumes, a key aspect of the business. All such deliveries were for major military platforms for leading US based Original Equipment Manufacturers, for the US government and for their Foreign Military Sales commitments, through the major Tier I OEMs. Rossell Techsys successfully expanded its capabilities into Fiber optic harnesses and has delivered orders recently, to the US Government, through federal sourcing entities, as well as for the Israeli Aerospace Industry. The Division also expanded its customer and geographic base, with total customers exceeding twenty-six (26).





In the financial year 2023-2024, Rossell Techsys has registered a record level of approximately ₹ 638 Crores of confirmed POs. This takes the total confirmed POs to approximately ₹ 900 Crores. Additionally, the Division has entered into Long-term Strategic Agreements with global customers to an extent of over ₹ 2,800 Crores. Such strategic agreements are with customers like Boeing, Lockheed Martin, Honeywell and Israeli Aerospace Industries. The purchase orders include a product mix of Electrical Wiring and Interconnect System (EWIS) sub-assemblies, Electrical Panel Assemblies (EPAs), Test Systems and Systems Integrated units.

Rossell Techsys continued to deliver to consistently high quality and delivery ratings and maintain its brand credibility of being uniquely different and refreshing to work with. The strategy of making investments in the initial stages of development or in enabling source transition, has been extremely encouraging in terms of long-term prospects.

On the Human Capital front, Rossell Techsys continued to maintain staffing levels commensurate with its revenue and growth needs. It has also focused on diversity and employment of people with disabilities under its diversity and Inclusion initiatives. The diversity stands at around 31% out of a total staff strength of 602, with differently abled, PWD candidates accounting for around 4% in the diversity mix. It has been able to contain attrition without major impact to its capacity, by focusing more on people agnostic processes to address the impact of attrition.

Rossell Techsys continues to maintain its leadership position in certifications that are crucial for operational excellence and covers diverse aspects from quality, environment, organizational health and safety, information systems, risk management and ethical transactions. It has successfully gone through recertification processes for several of its existing operational certifications. The Division is the only Indian company to have forty-six (46) special processes certified as part of its NADCAP AC7121 certification. The Division also successfully set up its metrology and calibration lab, certified to ISO/IEC 17025:2017.

Rossell Techsys continues its research and development recognition by the Department of Scientific and Industrial Research (DSIR) as an Industrial R&D unit. The Division shall continue to invest in R&D initiatives, alongside initiating the process of exploring external or government funding under the "Make in India" vision.

Prospects

Rossell Tea

The Orthodox market opened quite firm on the backdrop of lower production in India and Sri Lanka. A large number of producers in India have reverted back to CTC in the first flush, leading to lower Orthodox production by 2.2 million kgs. This has resulted in higher price realization for high quality and compliant orthodox teas produced by Rossell Tea.

The CTC market too has opened strong owing to lower crop. Also, what is being noticed this year is more teas are getting tested and that compliant and good quality teas are getting a premium. This clearly is advantageous for Rossell Tea.

Production in Sri Lanka in the beginning of the season is lower by 2 million kgs from last year.

However, production in Africa is on the rise and Kenya is significantly higher by 26 million kgs till end February. The latest available report indicates that the production in East Africa is increasing but there has been a decline in quality which has resulted in substantial quantity of over 45% of the offerings remaining unsold. To-date price average at Mombasa auctions is \$2.11 as compared to \$2.16 last year.

In Sri Lanka due to shortage of teas on offer, the average price at the auctions has shot up substantially and is around ₹ 120 per kg more than the prevailing orthodox prices in India. As per the latest information available even at the last auction held in Colombo, the market was very strong with aggressive buying from most of the importers.

In conclusion good quality and compliant CTC would continue to sell at remunerative prices and anything below good will decline in prices as arrivals increase. The Orthodox category is likely to remain firm as there is strong demand and production is low. Thus, prices will certainly be better than last year and in line with 2022.

We are happy to state that for the 1st time we have been able to conclude a contract for March/April teas from Romai TE with the most reputed buyer, Taylors of Harrogate, UK at remunerative prices and the firm contract from May to October would be signed off soon. Also, we are likely to sign additional contract with Taylors for supply of Orthodox teas from Dikom and another milestone is being achieved as Nagrijuli is being added to their list of suppliers and, for a start, 5 containers are being contracted. Another contract has been made with Ahmad Tea for supply of 1.60 lakh kgs tea from Dikom, Kharikatia and Nagrijuli. We are very hopeful that with progress of the season, we would be able to procure more export orders from Germany, UAE, UK and Saudi Arabia.



To summarize, we see the production being lower than last year due to adverse weather conditions. Since more testing of teas is being undertaken, this will restrict the use of chemicals and availability of compliant teas.

Thus, the orthodox prices will be better than the previous year. Similarly, CTC prices may be somewhat similar to last year but marginally better for us owing to our compliance and quality.

Rossell Techsys

The Financial Year 2024-2025 has every indication of reporting better results for the Rossell Techsys. The number of customers that should be added further could be more than 30%. The Division continues to receive opportunities in diverse areas in Electrical Wiring and Interconnect Systems, Complex Consoles, Box builds, Automatic Test Equipment, Electrical Panel Assemblies and After Market product support services. The philosophy of risk sharing on the right opportunity and for new customers has had its rewards. This has provided Rossell Techsys the opportunity to further enhance its skill and capability in electrical panel assemblies and systems integration.

The long-term outlook for Rossell Techsys is optimistic, and further major investment decisions will be undertaken after the segregation of the Division is complete. These investments shall be to tap the enormous potential, by building more capacity and capability. The Division has signed up with third party entities for providing expanded global sales support in Israel, Europe and the US. It is expected that with these new relationships, Rossell Techsys shall be able to make further breakthroughs with more customers and in adjacent technology areas, domains and geographies. The outlook is extremely positive with enormous confidence that the Division shall see significant growth levels. A total of ₹ 1,000 Crores worth of bids remain to be decided and has been delayed on account of leadership and executive changes within the customer organizations. It is expected that in the next 6 months, decisions on these bids would be taken. Therefore, Rossell Techsys is confident of adding more orders.

Change in Nature of Business

During the year, there has been no change in any business and all the Divisions of the Company continue to concentrate on their own business with growth plans in short to medium terms.

However, the Hon'ble National Company Law Tribunal, Kolkata Bench has pronounced its final Order very recently for sanction of the Scheme of Arrangement between Rossell India Limited ('the Demerged Company' or "the Company") and Rossell Techsys Limited ('Resulting Company').

In accordance with the aforesaid Order, Rossell Techsys Division (Demerged Undertaking) would be demerged from the Company and vest with Resulting Company on going concern basis immediately upon the said Scheme become effective.

The Scheme will become effective from the date on which the certified true copy of the said Order would be filed with the Registrar of Companies, Kolkata, which is awaited.

Directors and Key Managerial Personnel

As reported in the previous year, the Board of Directors at its meeting held on 27th May, 2023, on the recommendation of the Nomination and Remuneration Committee, has re-appointed Mr. H M Gupta (DIN: 00065973) as the Managing Director designated as Executive Chairman for a further period of 3(three) consecutive years with effect from 1st April, 2024, to hold office till 31st March, 2027. This reappointment was approved by the Members of the Company at 29th Annual General Meeting of the Company held on 3rd August, 2023.

Also reported in the previous year, the Board of Directors at its meeting held on 27th May, 2023, on the recommendation of the Nomination and Remuneration Committee, has re-appointed Mr. N K Khurana (DIN: 00123297) as a Whole time Director designated as Director (Finance) and Company Secretary for a further period of 3(three) consecutive years with effect from 1st September, 2023 to hold office till 31st August, 2026. This re-appointment was approved by the Members of the Company at 29th Annual General Meeting of the Company held on 3rd August, 2023.

Upon completion of her first term, Ms. Nayantara Palchoudhuri (DIN: 00581440) was re-appointed on 8th February, 2023 as an Independent Director of the Company for a second term of 5(five) consecutive years with effect from 9th February, 2023, to hold office till 8th February, 2028. The re-appointment was made by the Board of Directors on the recommendation of Nomination and Remuneration Committee and was approved by the Members of the Company on 23rd April, 2024 through Postal Ballot by way of remote e-Voting process only.

Mr. R M Gupta (DIN: 05259454) (RMG) has retired from the office of Whole time Director of the Company w.e.f. 9th February, 2024, in terms of the special resolution passed at 27th Annual General Meeting of the Company held on 9th September, 2021.





Keeping in view the object of Scheme of Arrangement between Rossell India Limited (Demerged Company) and Rossell Techsys Limited (Resulting Company) to take over the existing business undertaking of Rossell Techsys Division of the Company and proposal from the Board of Directors of Rossell Techsys Limited to appoint him as the Managing Director of the Company, RMG considered it prudent to vacate the office of Director of Rossell India Limited.

Accordingly, he submitted his resignation letter to the Board of Directors for his resignation from the office of the Director of the Company w.e.f. 9th February, 2024. The Board, at its meeting held on 5th February, 2024 has accepted his resignation as a Director of the Company. Thus, he ceased to be the Director of the Company w.e.f 9th February, 2024.

In keeping with the requirement of Regulation 17(1) (a) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, the Board, at its meeting held on 5th February, 2024 has elevated Ms. Samara Gupta (DIN: 09801530) to the Board by appointing her as Whole time Director of the Company upon recommendation of the Nomination and Remuneration Committee as well as Audit Committee, for a period of 3 (three) consecutive years commencing from 9th February, 2024. The Members approved the said appointment by passing special resolution on 7th April, 2024 through Postal Ballot by way of remote e-Voting System only.

Mr. N. K. Khurana, being the rotational director of the Company under Section 152 (6) of the Companies Act, 2013 (the Act) retires by rotation and being eligible offers himself for re-appointment.

Pursuant to the aforesaid Order, Rossell Techsys Division (Demerged Undertaking) would be segregated from the Company and vest with Resulting Company on going concern basis immediately upon the said Scheme become effective.

The Scheme will become effective on the date on which the certified true copy of the said Order would be filed with the Registrar of Companies, Kolkata, which is awaited.

In terms of the aforesaid Scheme, the existing total paid-up share capital of the Resulting Company held by the Company as on the effective shall stand cancelled without any further act immediately upon the Scheme become effective and allotment of Equity Shares by Resulting Company to the Shareholders of the Company. Thereafter, the Resulting Company shall cease to be the Wholly Owned Subsidiary of the Company.

Further, in effect to the demerger of Rossell Techsys Division from the Company, Rossell Techsys Inc. USA which was incorporated for expansion of operation of Rossell Techsys Division of the Company, would also get separated from the Company and transferred to Resulting Company. Hence, Rossell Techsys Inc. USA would also ceased to be the Wholly Owned Subsidiary of the Company.

The accompanying Note 50 to the Audited Accounts contains detailed financials of the said Subsidiary.

Since the Scheme of Arrangement is yet to be effective, Consolidated Financial Statements have also been prepared and forms part of this Annual Report of the Company for the Financial Year 2023-2024.

Your Company do not have any Joint Venture or Associate Company within the meaning of Section 2(6) of the Act, during the year under review.

Your Company's business faces various risks - strategic as well as operational in respect of all its Divisions. 





Rossell Tea

Industry Structure and Development

The total worldwide tea production in 2023 was around 6,604 million kgs, of which the main producers are China – 3,250 million kgs, India – 1,368 million kgs, followed by Kenya with a production of 570 million kgs and Sri Lanka with a production of 256 million kgs.

All countries recorded an increase over 2022 levels except Indonesia & Uganda.

According to the Tea Board statistics released for the period January to December 2023, Indian Tea exports stood at 227.91 million kilograms, compared to 231.08 million kilograms the previous year, reflecting a decrease of 3.17 million kilograms. The exports from North India totaled 137.55 million kilograms, a decrease of 9.78 million kilograms compared to the previous year. The export to Iran, the major importer of Orthodox tea, was 5.92 million kilograms, significantly lower than the previous year's 22.21 million kilograms, marking a decline of 73%. Weather continues to play a vital role in tea production. We have been witnessing extreme weather conditions in the last decade with prolonged hot/dry weather followed by extremely wet and overcast conditions with low temperatures. The occurrence of thunderstorms and hail storms has also increased. Climate change has impacted tea production particularly the old tea areas. This year recorded the lowest rainfall in the last 5 years with some areas in Assam recording the lowest in the last 30 years. Temperatures on the other hand were about 1-2 degrees higher than the normal.

This year was unique for Assam, with low prices and reduced production leading to financial losses for the majority of companies in the industry. The orthodox price realization was abysmally low compared to the previous year by 22%. Rossell Tea continues to upgrade its assets, be it the fields by uprooting, rejuvenation and replanting; and also the factories. All the Company's capital expenditure programs were completed on schedule and put to use. Our workers are our greatest assets and we are continuously improving their living and working environment through better hygiene, sanitation, housing and water supply. All our Estates are availing benefits of Govt. schemes for sanitation, housing, water supply, electric supply, roads and some medical related benefits.

Opportunities and Threats

Production

The Global black tea production during 2023 was higher by around 122 million kgs or 1.88 %. Production was higher in all producing countries barring Indonesia and Uganda. China and Kenya recorded the highest gains.

Sri Lanka has started season 2024 on a marginally lower note as compared to 2023 and is 1.35 million Kgs behind in production till March.

Kenya and other African countries are recording high production and Kenya alone is ahead in crop by 26.77 million. Kgs till end February.

There is a huge stock of teas piled up and remaining unsold in Mombasa.

Production in India till end March 2024 was 96.10 million Kgs., 13.69 million kgs (12.47%) lower as compared to the previous year. The April crop is, however, likely to be significantly better.

Orthodox production this year is significantly lower and even Sri Lanka is trailing in crop, hence the prices for this variety are much higher as there is demand from the CIS and Middle East.

The CTC tea prices have also been higher on the backdrop of lower crop in March, 2024.

We expect the CTC prices for the best category of teas to be higher this year.

Opportunities

We are recognized internationally and in the domestic market as one of the best Assam quality tea producer with required residue compliance, both in the CTC and Orthodox categories. Therefore, we would be able to receive a premium for our quality produce, from both international and domestic buyers. Four out of our 6 estates are RA certified and all estates are FSSC compliant.





Additionally, with increased testing in the domestic market there is a higher demand for compliant teas.

We have the flexibility to switch from Orthodox to CTC and vice a versa, to some extent, depending on the market dynamics. Also, as the exchange rates are high this year, exporting tea will be advantageous.

According to provisions in the Assam Govt. Budget 2023-2024, the Government is providing water supply to almost all workers' colonies. Electric supply schemes are also being implemented. There are also proposals for the Government to take over education and medical facilities on the Tea Estates in a phased manner.

Recently, all our estates received ambulances from the Assam Govt.

The Assam Tea Industries Special Incentives Scheme, 2020 (ATISIS), which was earlier announced for 3 years till 31st March, 2023, has now been extended by 3-5 years by the Government of Assam. This will benefit the Tea Industry in Assam in the following manner:

- A) The Assam Agricultural Income Tax holiday has been extended till the Financial Year 2026-2027. Since 60% of the Profits earned in Plantation is subject to Agricultural Income Tax levied by the State Government, no income tax shall be payable on 60% of the Profits earned by your Company as all the Estates are located in Assam. This will enable your Company to plough back higher post-tax profits for development projects.
- B) Interest Subvention, which is provided under the Scheme as reimbursement of 3% Interest paid on Working Capital to Banks shall now be available for further 5 years till the Financial Year 2027-2028. This will reduce the interest cost to a great extent.
- C) The Orthodox Subsidy shall continue on Orthodox Production at ₹ 10 per Kg. till the Financial Year 2027-2028. Your Company is having dual manufacturing capabilities and switch to higher Orthodox Production, if the Market conditions are favourable for Orthodox. This would add to the Profitability of the Company.

Thus, all these incentives would help in reducing the Cost of Production and thereby improve upon the Profitability of the Company.

We have a limited production base and at times cannot meet the requirements of our foreign buyers. Also, our costs remain high due to this low production base, hence it is clearly an opportunity to acquire more estates and grow.

Threats

Owing to the global climatic changes, weather conditions continue to be very erratic and unpredictable. Tea being an Agri Product is dependent on the weather conditions and if we witness any erratic weather condition, then both our crop and quality are likely to suffer. The climate change also brings in new pest and disease for which certain chemicals which might not be permitted by the importing countries, must be sprayed under compulsion. If such situation arises, then there would be less exportable teas available from our Company, even if we have orders / enquiries from the overseas buyers.

The high production and low prices in Africa are posing a threat particularly in the CTC category as buyers are shifting to more procurement from Africa.

Price of tea in the Domestic market is purely governed by supply and demand, an overproduction leads to drop in prices.

Iran, one of the major Indian Orthodox buyers is currently going through financial crisis, with inflation at an all-time high owing to the sanctions. There has been no order placed for Indian Teas since Dec 2022.

Fully compliant and safe teas with RA certification shall also give us an edge over the others and will make us eligible to export our teas where EU MRL compliance and RA certifications are required.

Climate Change

In the last decade, this phenomena has become very important and has impacted the agricultural outputs of various products including that of tea.



Temperatures have generally been on the rise and distribution of rainfall has become erratic and unpredictable. There are prolonged dry spells coupled with long periods of excessive wet conditions leading to droughts and flooding in different areas.

In 2023 we experienced the lowest rainfall in the last 6 years with some areas recording a deficit of over 30%.

Owing to deforestation and the climatic changes the pest activity has increased considerably and we are also seeing new pests and diseases that have not been encountered before.

In tea growing areas of Assam, we are witnessing intense heat or continuous rainfall, both of which are creating impediments to anticipated production of quality and quantity. This is also intensifying the sudden pest attack.

However, at Rossell Tea we practice sustainable agriculture with practices of irrigation, drainage, shade planting etc. which partially reduces the impacts. We are also creating water bodies to mitigate against drought and harvest rainwater during the rainy season.

Consumption

The overall consumption in the Indian subcontinent is more or less static with only approx. 3% growth coming primarily from the increase in population. The per capita consumption of 850 gms continues to be rather low.

High inflation and recession in most countries is leading to less demand particularly in rural areas and in the conflict areas across the globe.

Quality

The Company's stated policy and practice is to produce the best possible quality of CTC and Orthodox Tea. With consistent delivery on this front, we have built brand equity for the company and are today a benchmark for the industry in the international as well as domestic market for both Orthodox and CTC teas.

However, with other producers in the industry improving their quality, the competition is becoming more intense. Competitive prices have to be quoted for retaining our overseas clients, who were primarily acquired over the last decade.

Markets

The demand for better quality produce is currently concentrated around UK, Germany, Middle East countries and in some parts of USA, who are well known to pay premiums for better quality produce from India. The traditional markets in CIS Countries and certain other parts of Europe and Japan appear to be somewhat saturated and have become very price sensitive.

Rossell Tea shall maintain its clientele in UK, Germany and the Middle East countries but competitive pricing will play a critical role in obtaining business. The Company continues to explore new markets and customers in Canada and USA.

Our endeavor during 2024 will be to try and sustain our results as one of the best profit-making Tea Company in Assam. By offering our compliant and safe product and maintaining our quality we are confident of gaining market share in the international market.

Segment-wise Business Performance

Tea manufactured at our estates from own leaf during the Financial Year was 46.64 lakh kgs as against 51.99 lakh kgs in 2022-2023, lower by 5.35 lakh kgs or 10.29%.

Made tea from outsourced leaf was 5.03 lakh kgs compared to 4.61 lakh kgs in the previous year and our total tea production at 51.67 lakh kgs.

Production was impacted due to inadequate rainfall this year as extreme weather conditions were experienced especially in Upper Assam where 4 of our estates are located. Some areas recorded a deficit of over 30% rainfall and the lowest in the last 30 years. Increased pest incidence and restriction on use of chemicals due to MRL's is another factor impacting production.

All India production improved from 1,365 million kgs to 1,368 million kgs an increase of 0.2 %.





Exports for Rossell Tea during the year was 9.22 lakh kgs as compared to the previous year's quantity of 6.32 lakh kgs. The higher exports were due to the fact that we were able to export more teas to UK, UAE, Germany and Canada.

Price realization for our teas at ₹ 274.26 was lower than the previous year's average of ₹ 290.29 per kg by 5.52%. This was on the backdrop of significantly lower orthodox prices due to the muted demand.

Input costs of fuel, fertilizers, chemicals, packing materials, etc. were higher. The daily rated workers' wages increased by 7.76% from 1st October 2023. Our product mix, efficiencies and productivity helped in obviating the costs to some extent.

The total income of the Division at ₹ 150.81 Crores versus the previous year's income of ₹ 168.90 crores which was the highest ever achieved by the Division.

d. Outlook

The year 2024 has started with adverse growing conditions mainly inadequate rainfall in Assam and West Bengal resulting in poor cropping during the period of January to March 2024 wherein the production in North India stands at 48 million kgs as compared to 69 million kgs last year. Extreme and varying climatic conditions are impacting crop and production.

Production in Sri Lanka for the January to March 2024 period is lower by 2 million kgs from last year. Production in Africa is on the rise and Kenya is significantly higher by 26 million kgs till end February. The latest available report indicates that the production in East Africa is galloping but there has been a decline in quality which has resulted in a substantial quantity of over 45% of the offerings remaining unsold. To-date price average at Mombasa auctions is \$2.11 as compared to \$2.16 last year. It is estimated that there is around 180 million kgs stockpiled in Africa. In Sri Lanka due to shortage of teas on offer, the average price at the auctions has shot up substantially and is around ₹120 per kg more than the prevailing orthodox prices in India. As per the latest information available even at the last auction held in Colombo, the market was very strong with aggressive buying from most of the importers despite the ongoing conflict between Russia and Ukraine and West Asia. Sri Lanka has entered a barter system with Iran for its Tea exports against procurement of Oil.

In India the Orthodox market which was very sluggish and subdued in 2023 opened quite firm on the backdrop of lower production in India & Sri Lanka. Moreover, seeing the dismal market for orthodox teas in 2023 a large number of producers in India have reverted back to CTC in the first flush of 2024 resulting in lower Orthodox production of 2.2 million kgs.

The CTC market too has opened strong owing to lower crop production. Also, what is being noticed this year as more teas are getting tested is that compliant and good quality teas are getting a premium. This clearly is advantageous for us. Good quality and compliant CTC would continue to sell at remunerative prices and anything below good will decline in prices as arrivals increase. The Orthodox category will remain firm as there is demand and production is low and we expect prices will be better than last year and in line with 2022.

We at Rossell Tea despite the adversity – weather conditions and increase in costs continue to be in touch with all our customers in UK, Germany and the Middle East. We are happy to state that for the first time we have been able to conclude a contract for March/April teas from Romai TE with the most reputed buyer, Taylors of Harrogate, UK at remunerative prices and the firm contract from May to October is likely to be signed off soon. Also, we are likely to sign an additional contract with Taylors of Harrogate to supply some Orthodox teas from Dikom. Another milestone is being achieved as Nagrijuli is being added to their list of suppliers and to begin with 5 containers are being contracted. Another contract has been made with Ahmad Tea for the supply of 1.60 lakh kgs tea from Dikom, Kharikatia and Nagrijuli.

We are very hopeful that as the season progresses, we will be able to procure more export orders from Germany, UAE, UK, and Saudi Arabia. The Indian Tea Industry is faced with several issues, some of them are highlighted hereunder:

- Climate change & vagaries of nature/extreme weather is affecting the production and quality.
- Low per capita consumption of tea.
- Increasing production in the STG segment, over supply of average/medium quality of tea.
- Exports dropping in favor of countries like Africa, Nepal, Vietnam etc.
- There is likelihood of either minimum wages or living wage being announced towards the end of the year.



To summarize, we anticipate the production being lower than last year due to adverse weather conditions and the increased testing of teas will restrict the use of chemicals. CTC prices may be somewhat similar to last year but marginally better for us owing to our compliance and quality. The orthodox prices will be better than the previous year. The biggest challenge will be to protect the crop and rein in the escalating costs particularly wages and fuel.

Risks and Concerns

The ongoing war between Russia and Ukraine and "global recession" will play an important role on the purchasing power of the consumers. This is already impacting the demand and tea prices across the globe. The conflict in several countries in West Asia and shipping disruption in the Red Sea is impacting the supply chain to a great extent and shipping costs have surged.

Weather continues to play an important role in the success or failure of any agro-horticultural produce including tea plantations. The EL-NINO effect is being felt in India with high temperatures and extreme weather conditions.

Good agricultural practices and timely intervention can obviate and mitigate the loss to some extent. Planting trees and augmenting irrigation to counter droughts and adequate drainage for countering floods are some measures being adopted.

Buyers in the Domestic and International markets are clamoring and insisting on compliant and safe teas. Domestically there is a challenge on getting all the small growers to use only approved chemicals, this may also lead to lower production.

There are some external factors which are of concern, and these are being addressed with the concerned authorities through the Industry associations and bodies:

- Exports are also likely to be impacted due to the sluggishness in Global Trade in view of the conflicts and the very high inflation being experienced worldwide.
- CTC exports are likely to be impacted due to the high prices in the Domestic market and conversely lower prices in Kenya. A lot of global buying is shifting to Africa because of its location.
- Disruption in shipping through the Red Sea is also leading to supply chain woes and higher shipping costs.

There is need to produce quality tea to average higher price realisations and this continues to be a priority for the Company.

Rossell Techsys

a. Industry Structure and Development

The Global Aerospace and Defense industry continues to be on the path to recovery despite the challenges from the dynamic geopolitical-economic situation, conflicts, changing global equations, and rising internal political uncertainties across the globe. The business outlook is cautiously positive, but companies are adopting caution in planning.

The geo-political-economic situation has given rise to a sense of insecurity among Nations and is necessitating increases in GDP spend across many countries, especially in the western world. According to the Stockholm International Peace Research Institute (SIPRI), the total military spend has reached an all-time high of \$2.24 trillion. The United States which accounts for close to 40% of the military spend, increased its spend by an additional 1%. The global GDP percentage spend in military expenditure grew by a whopping 34% in comparison to previous years. Finland became the 31st country to join NATO with an increase in defense spending to an extent of 36%. Even a small country like Lithuania has increased defense spending by 27%. Japan's military spend grew by close to 6%, Germany increased spend by 1.6%. India grew its defense spend by close to 6%.

On the domestic front, India is pushing all OEMs to respect and honor the "Make in India" vision. This coupled with the recent government policies are driving defense manufacturing to record levels. The annual growth is expected to be greater than 12%, well poised to meet the \$25B manufacturing target by 2025. India is also poised for the fastest growth in the commercial aerospace world. Air India and Indigo have placed orders for close to 1,000 planes totaling a massive \$150B+ in spend. This coupled with the Government of India push to open more airports across the length and breadth of the country, has enormous potential for increased spend in commercial aviation, including the integrated eco-systems for maintenance, ground support, and other direct and indirect ancillary and service industries.





The Global Supply Chain has seen an enormous impact on account of the geo-political- economic imbalances, accentuated by the ongoing Russia-Ukraine conflict and the changing political equations between countries. Ukraine and Russia are two countries that source major metals such as titanium, nickel as well as process these raw materials for use globally. These are used in various parts in the Aerospace and Defense Segment, an area that the Division has been operating in for the last decade. Prices of raw material have skyrocketed, due to various factors, a major factor being predatory mergers and acquisitions, especially by Private Equity Firms, literally making the supply chain unviable and seriously challenging the Aerospace and Defense industry. The Division is cognizant of this and has taken measures proactively of creating alternates in material and sources, to the extent it can. The long-term outlook for the Division remains very bright, due to the sheer number of opportunities that it is working on, increased customers and a more balanced geographic customer spread.

In line with its forward-looking philosophy, the Division continues to look beyond the near term, capitalizing on its strong brand and credibility. It recommends organic and inorganic growth domestically as well as globally, in existing as well as in adjacent competency areas and based on opportunities presented by its customers. For inorganic growth, the Division is looking out for right size prospects, globally, and in an opportunistic manner.

b. Opportunities and Threats:

The Division has been able to successfully navigate, in most cases, near-term challenges, such as the supply chain, on price and lead time. During the near term, the Division is cognizant of the need to increase higher value-added services to its customers. The Division desires to stay ahead of the curve and continue to invest strategically during this time.

The major opportunity seen today is in expanding geographically rather than remaining concentrated to a single country. The reason being that most countries would like to safeguard their military interests starting with the supply chain and have as much as local manufacture as possible. Already, some competing companies have started diversifying geographically. The company too, would do well to take advantage of this global need.

As most of the customers for the company are from the western world, the USA in particular, it is only natural to invest in the subsidiary that the company has and perform more activities, including manufacture. Towards this end, the subsidiary company has registered with the Department of Defense Trade Controls (DDTC) and has set up basic infrastructure to meet the needs of ITAR and EAR programs. Further, it has also taken steps to register directly with the USG government to take advantage of the small business benefits that the US government provides in the form of directed business. Such business will be supported by the company in India, at the back end.

c. Segment wise Business performance

The total Operational revenue for the financial year 2023-2024 stands at ₹ 216.88 Crores, an increase of around 16.32% over the previous fiscal year 2022-2023. The Division added confirmed orders worth ₹ 638.00 Crores and confirmed strategic agreements worth around ₹ 2,800 Crores.

The company has seen interest from the domains of Space, Land, High power electric vehicles, transportation and sea. It is estimated that each of these segments will follow the natural life cycle for growth and reach its full potential in the next 3 to 5 years. Till then the company shall continue to nurture such opportunities for growth.

On the capability side, the company has experienced increased interest in automatic test systems and systems integration of systems and assemblies. This shall enable the company to move in the direction of forward and vertical integration of domains as well as competencies.

d. Outlook

The overall outlook of the Division looks positive and encouraging. It is keeping a keen eye on execution, focusing on quality improvements, efficiency improvements, optimization, automation, and hiring and retaining high caliber human capital. The Division is focusing on diversification and expansion, to take hold of the rising opportunities. As the Division scales, it is also ensuring that it retains its global operating culture.



It is essential that in order to tap the potential of the business, the company make significant capital investment. During the pandemic and post the pandemic, the company has been conservative and has adopted a minimal risk approach to capital investments. This approach needs to change in FY 2024-25 and during the next three fiscal years. Such investment, in geographic expansion as well as inorganic capability enhancement is expected to reap huge benefits riding atop the strong brand image of the company. Customers are keenly looking forward to such expansion.

e. Risks and Concerns

The unbridled price rises, delayed lead times, are often brought about by mergers and acquisitions. Many Private Equity firms have sensed this insecurity of the end customers and have resorted to take advantage of this weakness to maximize their profits. Such price rises can be managed better by companies with high buying power and with volume business.

Post the pandemic, it has become more difficult to get people back to work, physically on the shop floor. As the world economic order goes through correction, this threat is seen for the short and near term with confidence that economic correction will eventually address people availability. Further, the Division has changed its hiring and retention strategy to retain its best and most valuable human capital so that the effects of attrition are minimal. The Division has also significantly improved its process robustness minimizing people dependency.

f. **Internal Control System and their Adequacy**

There are adequate Internal Control systems at all levels of Management of the Company. They are reviewed periodically and improved upon, where required.

The Internal Audit is carried out by competent professionals. The Audit Committee of the Board looks into Auditors observations, which are deliberated upon, and appropriate directives are issued to the concerned Division for taking corrective measures forthwith.

Financial and Operational Performance g.

Besides the continuous emphasis on quality enhancement of products and services, prudent cost management has been the objective of all the Divisions of the Company.

The Operating Profit before depreciation and interest (EBITDA) of the Rossell Tea Division for the year was ₹ 1,198.59 lakhs as against ₹ 3,007.59 lakhs in the previous year.

At the same time the Operating Profit before depreciation and interest (EBITDA) of the Rossell Techsys Division for the year was ₹ 3,553.36 lakhs as against ₹ 3,127.04 lakhs in the previous year.

With the strong financial fundamentals over the year, the financial base of your Company remains strong, and it shall be further strengthened with better operating and financial performance in the years ahead, subject to the impact of demerger process being in progress at this stage.

Human Resources Development h.

Human resources are the most valuable assets of the Company – at corporate level as well as at Divisions/ Estates.

Industrial relations at both the Divisions of the Company remain excellent. Your Company employs 5,619 personnel on its permanent roll.

- All new acquisitions of Machinery are planned with a view towards energy and fund conservation.
- Consent for installing solar power sent to the Govt/APDCL. Installation of a 240 KWp Solar plant at Kharikatia under OPEX model has been installed in collaboration with Tata Power Solar.
- Conventional pipe Gas burners at Dikom replaced for lowering consumption with better combustion/blue flame.
- Old gas pipeline replaced and put above the ground at Dikom and Nokhroy for longevity. Hydraulic testing of gas supply pipeline was conducted for all Estates receiving gas. Leaking/worn out valves were replaced to ensure no loss of gas.



- Fuel efficient Gas burners at Nokhroy and Romai have been recalibrated to get blue flame which indicates optimum combustion of gas.
- Cleaning of old and installation of additional perpex /transparent roof sheets to save on electricity.
- Enhancement in Mechanization of pruning operations- additional pruning machines were provided for improving pruning/work standards and timely completion.
- Halogen bulbs replacement with LED bulbs is ongoing.
- Water flow meters have been installed to measure and monitor water pumping.
- Reduction in chemical usage by adopting early detection/search & kill in initial stages to avoid harmful spraying.
- Reduction in N (Urea) & K (MOP), introduction of Nano Urea.

- 2. Nature and purpose of each Reserve

a) Capital Reserve

This represents the amounts received as compensation for Tea Estates Land acquired by competent authorities on various occassions as well as certain adjustments relating to various Schemes of Arrangements, which the Company had entered in to in the earlier years.

b) Securities Premium Reserve

Securities Premium Reserve was created as per the Scheme of Arrngement with the value of net assets taken over by the Company and again used to credit the premium on issue of Equity Shares by the Company from time to time, including the recent issues (Notes 2 and 3 above). The reserve is available for utilisation in accordance with the provisions of the Companies Act, 2013.

c) General Reserve

General Reserve is created for ploughing back the profits earned by the Company and retained before payment of dividend. This is free reserve and available for utilisation in accordance with the provisions of the Companies Act, 2013.

d) Retained Earnings

Retained earnings represent accumulated profits earned by the Company and remaining undistributed as on date.

Material Accounting Policies and Other Notes to the Financial Statement for the Year ended 31st March, 2024

Company Overview

Rossell India Limited (the Company) is a Public Limited Company incorporated and domiciled in India. The Company was incorporated on 10th June, 1994 under the Companies Act, 1956 with its registered office at Kolkata, West Bengal. The Equity Shares of the Company are listed on National and Bombay Stock Exchanges. The Company is engaged in the following business

- Cultivation, Manufacture and Sell of Bulk Tea- The Company own six Tea Estates all located in Assam.
- Engineering and Manufacturing in Aerospace and Defense Services.

2.1.1 Basis of Preparation

These financial statements have been prepared in accordance with Indian Accounting Standard (Ind AS) as per Companies (Indian Accounting Standards) Rules, 2015 (as amended) notified under Section 133 of the Companies Act, 2013 (the Act) and the other relevant provisions of the Act and Rules made thereunder as well as the other accounting principles generally accepted in India.

2.1.2 Basis of Measurement

The financial statement has been prepared on a historical cost basis except the following items:

- Certain financial assets and liabilities (including derivative instruments) which are measured at fair value.
- Biological Assets other than Bearer Plants, which are measured at fair value less cost to sell.
- Defined benefit plans plan assets measured at fair value.

2.1.3 Use of estimates and judgements

The preparation of financial statements in accordance with Ind AS requires management to use of certain critical accounting estimates, judgments and assumptions. It also requires management to exercise judgment in the process of applying accounting policies. Actual results could differ from those estimates. These estimates, judgments and assumptions affect application of the accounting policies and the reported amounts of assets, liabilities, revenue, expenditure, contingent liabilities etc.

The estimates and underlying assumptions are reviewed on an ongoing basis and changes are made as management becomes aware of changes in the circumstances surrounding the estimates. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the Company and that are believed to be reasonable under the circumstances. Revisions to accounting estimates are recognized in the financial statements in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current and future periods.

2.2 Classification of current and non-current

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Ind AS 1- Presentation of financial statements and Schedule III to the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current / non-current classification of assets and liabilities.

3 **Material Accounting Policies**

Property, Plant and Equipment 3.1

3.1.1 Tangible Assets (Other than Bearer Plants)

Property, Plant and Equipment are measured at cost / deemed cost, less accumulated depreciation and impairment losses, if any. Cost of Property, Plant and Equipment comprises its purchase price, including import duties and non-refundable purchase taxes, after deducting trade discounts and rebates, any directly attributable cost of bringing the item to its working condition for its intended use and estimated attributable costs of dismantling and removing the item and restoring the site on which it is located. Deemed Cost is the carrying value of all of its Property, Plant and Equipment (other than Bearer Plants) as of 1st April, 2016 measured as per the previous GAAP as the Company elected to continue with the same carrying value as on the aforesaid transition date for Ind AS date for Ind AS.

Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced. All other repairs and maintenance are charged to the Statement of Profit and Loss during the reporting period in which they are incurred.





An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount. Any gain or loss on disposal of an item of Property, Plant and Equipment is recognized in Statement of Profit and Loss.

An item of Property, Plant and Equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of asset. Any gain or loss arising on the disposal or retirement of an item of Property, Plant and Equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognized in profit or loss.

Items of Property, Plant and Equipment are depreciated in a manner that amortizes the cost of the assets less its residual value, over their useful lives on a straight line basis. Estimated useful lives of the assets are as specified in Schedule II of the Companies Act. 2013.

The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period and the effect of any changes in estimate is accounted for on a prospective basis.

3.1.2 Bearer Plants

Bearer Plants comprising of mature tea bushes as well as matured black pepper vines and shade trees are stated at cost / deemed cost less accumulated depreciation and impairment losses, if any.

The cost of uprooting of old tea bushes, rehabilitation of land, replanting and young tea upkeep and maintenance up to the year 3 from the year of planting are capitalized as mature plants, capital work-in-progress. From year 4 onwards capital work-in-progress is treated as Bearer Plants and depreciated using Straight Line Method over the expected useful life of 70 years, when the Bearer Plants (mature tea bushes) reaches maturity stage with residual value as 'Nil'.

Depreciation on Bearer Plants is recognized so as to write off its cost over useful lives, using the Straight Line Method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any change in estimate accounted for on a prospective basis.

3.1.3 Intangible Assets

Intangible Assets of the Company comprise acquired Computer Software having a finite life. Cost of software is capitalized when it is expected to provide future enduring economic benefits. The capitalization cost includes license fee, cost of implementation and system integration services. The costs are capitalized in the year in which the relevant Software is implemented for use and is amortized across a period not exceeding 10 years.

3.1.4 Research and Development

Research and Development costs are expensed as incurred unless technical and commercial feasibility of the project demonstrate that: (a) the future economic benefits are available, (b) the activity is being carried out with an intention and ability to complete as well as use the asset and (c) the cost can be measured reliably. In such case, the cost is capitalized as Intangible Asset – Knowhow. The cost which can be capitalized include the cost of material, direct labour, overhead costs including finance cost, if applicable that are directly attributable to bringing the asset for its intended use.

3.2 Foreign Currency Translation

Foreign currency transactions are translated into Indian Rupee (INR) which is the functional currency (i.e. the currency of the primary economic environment in which the entity operates) using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are recognized in profit or loss.

3.3 Revenue Recognition

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are inclusive of insurance claim for damage / shortage of finished goods and are net of sales return, GST and trade allowances.

The Company recognizes revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the Company and significant risk and reward incidental to sale of products is transferred to the buyer or services are rendered as per terms of the relevant contract.

3.4 Financial Instruments

Financial assets and financial liabilities are recognized when the Company becomes a party to the contractual provisions of the relevant instrument and are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issues of financial assets and financial liabilities (other than financial assets and financial liabilities measured at fair value through profit or loss) are added to or deducted from the fair value measured on initial recognition of financial assets or financial liabilities.



Purchase or sale of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognized on the trade date i.e. the date when the Company commits to purchase or sell the asset.

3.4.1 Financial Assets

Recognition and Classification

The financial assets are classified at initial recognition in the following measurement categories as:

- those subsequently measured at amortized cost. those to be subsequently measured at fair value [either through other comprehensive income (OCI), or through profit or loss]

Subsequent Measurement

- Financial assets measured at amortized cost Financial assets which are held within the business model of collection of contractual cash flows and where those cash flows represent payments solely towards principal and interest on the principal amount outstanding are measured at amortized cost. A gain or loss on a financial asset that is measured at amortized cost and is not a part of hedging relationship is recognized in profit or loss when the asset is derecognized or impaired.
- Financial assets measured at fair value through other comprehensive income Financial assets that are held within a business model of collection of contractual cash flows and for selling and where the assets' cash flow represents solely payment of principal and interest on the principal amount outstanding are measured at fair value through OCI. Movements in carrying amount are taken through OCI, except for recognition of impairment gains or losses. When a financial asset, other than investment in equity instrument, is derecognized, the cumulative gain or loss previously recognized in OCI is reclassified from equity to statement of profit and loss.

Classification of equity instruments, not being investments in subsidiaries, associates and joint arrangements, depend on whether the Company has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through OCI. When investment in such equity instrument is derecognized, the cumulative gains or losses recognized in OCI is transferred within equity on such derecognition.

Financial assets measured at fair value through profit or loss – Financial assets are measured at fair value through profit or loss unless it is measured at amortized cost or at fair value through other comprehensive income on initial recognition. Movements in fair value of these instruments are taken in profit or loss.

Impairment of financial assets

The Company assesses at each date of balance sheet whether a financial asset or a group of financial assets is impaired. Impairment losses are recognized in the profit or loss, where there is an objective evidence of impairment based on reasonable and supportable information that is available without undue cost or effort. For all financial assets, expected credit losses are measured at an amount equal to the 12 month expected credit losses or at an amount equal to the life time expected credit losses if the credit risk on the financial asset has increased significantly since initial recognition. The Company recognizes loss allowances on trade receivables when there is an objective evidence that the Company will not be able to collect all the due amount depending on product categories and the payment mechanism prevailing in the industry.

Income recognition on financial assets

Interest income from financial assets is recognized in profit or loss using effective interest rate method, where applicable.

Dividend income is recognized in profit or loss only when the Company's right to receive payments is established and the amount of dividend can be measured reliably.

3.4.2 Financial Liabilities

Financial liabilities are classified according to the substance of the contractual arrangements entered into. Financial liabilities are classified, at initial recognition, as subsequently measured at amortized cost unless they fulfill the requirement of measurement at fair value through profit or loss. Where the financial liability has been measured at amortized cost, the difference between the initial carrying amount of the financial liabilities and their redemption value is recognized in the statement of profit and loss over the contractual terms using the effective interest rate method. Financial liabilities at fair value through profit or loss are carried at fair value with changes in fair value recognized in the finance income or finance cost in the statement of profit or loss.

3.4.3 Derecognition of financial assets and financial liabilities

Financial assets are derecognized when the rights to receive benefits have expired or been transferred, and the Company has transferred substantially all risks and rewards of ownership of such financial asset. Financial liabilities are derecognized when the liability is extinguished that is when the contractual obligation is discharged, cancelled or expired.





3.4.4 Offsetting of financial instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet where there is a legally enforceable right to offset the recognized amounts and there is an intention to settle on a net basis or realize the asset and settle the liability simultaneously.

3.5 Derivatives and hedging activities

The Company do have derivative financial instruments such as forward contracts, and to mitigate risk of changes in exchange and interest rates, although nil outstanding at on 31st March, 2024. The counterparty for these contracts is generally banks.

3.5.1 Derivatives

Derivatives are measured at fair value. All fair value gains and losses are recognized in profit and loss except where the derivatives qualify as hedging instruments in cash flow hedges or net investment hedges.

3.5.2 Cash flow hedges that qualify for hedge accounting:

The Company designates their derivatives as hedges of foreign exchange risk associated with the cash flows of highly probable forecast transactions.

The Company documents at the inception of the hedging transaction the economic relationship between hedging instruments and hedged items including whether the hedging instrument is expected to offset changes in cash flows of hedged items.

The effective portion of changes in the fair value of derivatives that are designated and qualify as cash flow hedges is recognized in the Other Comprehensive Income.

3.6 Government Grants

Grants from the government are recognized at their fair value where there is a reasonable assurance that the grant will be received and the Company will comply with all attached conditions.

Government grants relating to income are deferred and recognized in the Statement of Profit and Loss over the period necessary to match them with the costs that they are intended to compensate and presented within other income.

Government grants relating to the purchase of Property, Plant and Equipment are included in non-current liabilities as deferred income and are credited to the Statement of Profit and Loss on a Straight Line basis over the useful life of the related assets and presented within other income.

3.7 Income Tax

The Income Tax expense or credit for the period is the tax payable on the current year's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses as well as available MAT Credit.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the reporting date. Current tax comprises of expected tax payable or receivable on taxable income / loss for the year or any adjustment or receivable in respect of previous year.

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognized for all taxable temporary differences. Deferred tax assets are generally recognized for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized. Such deferred tax assets and liabilities are not recognized if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Current and deferred tax are recognized in profit and loss, except when they relate to items that are recognized in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognized in other comprehensive income or directly in equity respectively.



3.8 **Inventories**

Stock of finished goods and stock-in-trade are valued at lower of cost and net realizable value. Finished goods, produced from agricultural produce viz. Black Tea and Tea Waste, are valued at lower of cost arrived at by adding the cost of conversion to the fair value of agricultural produce viz. Green Leaves and the net realizable value. Agricultural produces, viz. Green Leaves harvested from the Company's own Tea Estates, are valued at fair value less cost to sale at the point of harvest. Black Pepper, being an Agricultural Produce is also valued at the net realizable value.

Raw Materials purchased (including Bought Green Leaves) and Stores and Spare Parts are valued at or under cost. Work-in-progress is valued at works cost based on technical evaluation of the stage of completion.

Provision is made for obsolete, slow moving and defective inventories, wherever necessary and reviewed from time to time.

Costs are ascertained to the individual item of inventory by adopting weighted average method. Net realizable value is the estimated selling price for inventories less all selling costs.

3.9 **Biological Assets**

Biological Assets of the Company comprises of unharvested Green Tea Leaves. These are recognized as such when and only when, (a) the Company controls the assets as a result of past events, (b) it is probable that future economic benefits associated with such assets will flow to the Company and (c) the fair value or cost of assets can be measured reliably. These assets are measured at its fair value less cost to sell. The gain or loss arising from change in such value is included in Statement of Profit and Loss.

3.10 Agricultural Produce

Agricultural Produce of the Company comprises of harvested Green Tea Leaves as well as Black Pepper, from its own Tea Estates. These are valued at fair value less cost to sell on the reporting date. The gain or loss arising from change in such value is included in the Statement of Profit and Loss under the head Consumption of Raw Materials (Green leaves) or Change in inventories of Finished Goods, as applicable.

Employee Benefits

- **3.11.1** These are recognized at the undiscounted amount as expense for the year in which the related service is rendered.
- 3.11.2 The Company is contributing regularly to the Provident Funds, administered by the Governments and independent of Company's finances, in respect of all its eligible employees. The Company also operates Defined Contribution Scheme for payment of Pension to certain classes of employees. Monthly contribution at 15% of the eligible employees' current salary is made to recognized Superannuation Fund, which is fully funded. This Fund is administered by Trustees and is independent of Company's finance. Contributions are recognized in Profit and Loss Statement on an accrual basis.
- **3.11.3** Defined Benefit Gratuity Plan is also maintained by the Company. The Contributes to the recognized Gratuity Fund, which is administered by the Trustees and is independent of Company's finance. The Annual Contribution is determined by the actuary at the end of the year. Actuarial gains and losses are recognized in the Profit and Loss Statement. The Company also recognizes in the Profit and Loss Statement gains or losses on curtailment or settlement of the defined benefit plan as and when the curtailment or settlement occurs.

Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognized, in the year in which they occur, directly in Other Comprehensive Income and eventually included in retained earnings in the Statement of changes in Other Equity and in the Balance Sheet.

Changes in the present value of the defined benefit obligation resulting from plan amendments or curtailments are recognized immediately in the Statement of Profit and Loss as past service cost.

3.11.4 Leave encashment liability for eligible employees is provided for at the end of the year, as actually computed and paid/provided for and the charge is recognized in the Profit and Loss Statement.

3.12 Leases

Leases are recognized as per Ind AS 116 when there is a contract that conveys the right to control the use of an identified asset. Such leases are amortized over the lease term.

3.13 Borrowing costs

Borrowing costs consist of interest and related costs incurred in connection with the borrowing of funds. Borrowing costs also include exchange differences to the extent regarded as an adjustment to the borrowing costs.





Borrowing costs that are attributable to the acquisition or construction of qualifying assets or for self-created assets (i.e. an asset that necessarily takes a substantial period of time to get ready for its intended use) are capitalized as a part of the cost of such assets. All other borrowing costs are charged to the Statement of Profit and Loss.

3.14 Provisions and Contingent Liabilities

Provisions are recognized when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that the Company will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

The amount recognized as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking in to account the risks and uncertainties surrounding the obligation.

Contingent liabilities are possible obligations whose existence will only be confirmed by future events not wholly within the control of the Company or present obligations where it is not probable that an outflow of resources will be required or the amount of the obligation cannot be measured with sufficient reliability.

Contingent liabilities are not recognized in the financial statements but are disclosed unless the possibility of an outflow of economic resources is considered remote.

3.15 Operating Segments

In terms of Ind AS 108, Operating segments are reported in a manner consistent with the internal reporting provided to the Chief Operating Decision Maker (CODM) viz. the Chief Executive Officer (Executive Chairman) of the Company. The Chief Operating Decision Maker is responsible for allocating resources and assessing performance of the operating segments, which are engaged in separate business activities from which it earns revenue and incur expenses. For each of the segments discreet Financial Results are available.

An amount of ₹ 1,032.72 Lakhs (2023 – ₹ 1,006.75 Lakhs) has been charged to the Statement of Profit and Loss on account of defined contribution schemes.

The Company also operates defined benefit scheme in respect of gratuity benefit towards its employees. This scheme offers specified benefits to the employees on retirement, death, disability or cessation of employment. - (i) Interest rate risk: The defined benefit obligation calculated uses a discount rate based on government bonds. If bond yields fall, the defined benefit obligation will tend to increase.
- (ii) | Salary inflation risk: Higher than expected increases in salary will increase the defined benefit obligation.
- (iii) Demographic risk: This is the risk of variability of results due to unsystematic nature of decrements that include mortality, withdrawal, disability and retirement. The effect of these decrements on the defined benefit obligation is not straight forward and depends upon the combination of salary increase, discount rate and vesting criteria. It is important not to overstate withdrawals because in the financial analysis the retirement benefit of a short career employee typically costs less per year as compared to a long service employee.

Financial risk management objectives

The Company's business activities expose it to certain financial risks - market risk, liquidity risk and credit risk. In order to minimize those risks, the Company has risk management policies and procedures in place as approved by the Risk Management Committee of the Board of Directors of the Company after due evaluation of key risks facing the business of the Company:

a) Market Risk

The Company's business of Cultivation, Manufacture and Sale of Tea is primarily agricultural in nature and subject to vagaries of nature. Moreover, the sale price of Tea is largely determined by the market forces of demand and supply. Thus, adverse weather conditions and uncertain tea market expose it to the risk that the fair value or future cash flows may adversely fluctuate. The Company closely monitors the changes in market conditions and select the sales strategies to mitigate its exposure to various market risks. Other Market risks are as under:

i. Foreign Currency Risk

The Company undertakes significant transactions denominated in foreign currency with its customers in relation to Exports by Rossell Tea Division and 100% EOU of Rossell Techsys Division. This results in wide exposure to exchange rate fluctuations. Such exchange rate risk primarily arises from transactions made in foreign exchange and reinstatement risks arising from recognized assets and liabilities, which are not in the Company's functional currency (Indian Rupees). A significant portion of these transactions are in US Dollar, Euro, British Pound Sterling etc.

The Company, as Risk Management Policy, hedges its exposure in foreign exchange whenever considered appropriate based on their perception about such market and reviews periodically its exposure therein to ensure that results from fluctuating currency exchange rate are appropriately managed.

ii. **Interest Rate Risk**

Interest rate risk refers to the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The objectives of the Company's interest rate risk management processes are to lessen the impact of adverse interest rate movements on its earnings and cash flows and to minimize counter party risks.

The Company is exposed to interest rate volatilities primarily with respect to its borrowings from Banks. Such volatilities primarily arise due to changes in the Lending rates of Banks, which in turn are linked with Repo Rates as announced by RBI from time to time as well as other economic parameters of the Country. The Company manages such risk by operating with Banks having strong fundaments with comparatively lower Lending Rates in the Market.

Interest rate sensitivity

Since the significant amount of borrowings of the Company are short term in nature, the possible volatility in the interest rate is minimal.





b) Liquidity Risk

Liquidity risk is the risk that the Company may encounter difficulty, including seasonality, in meeting its obligations due to shortage of liquid assets.

The Company mitigates its liquidity risks by ensuring timely collections of its trade receivables, close monitoring of its credit cycle, ensuring optimal movements of its inventories and avoid blockage of working capital in non-productive current assets.

c) Credit Risk

Credit risk is the risk that counter party will not meet its obligations leading to a financial loss to the Company.

The Company has its policy to limit its exposure to credit risk arising from outstanding receivables. Management regularly assesses the credit quality of its customer's based on which, the terms of payment are decided. Credit limits are set for each customer, which are reviewed at periodic intervals. The credit risk of the Company is low as the Company sells a significant volume of its Teas through the auction system which is on cash and carry basis. The exports are made mostly to worldwide reputed Corporates like Boeing, Lockheed Martin, Taylors of Harrogate etc., and otherwise backed by letter of credit or on advance basis.

There is no expected credit risk on Trade Receivables as on 31st March, 2024 (Note 16).

The Board of Directors at their Meeting held on 12th July, 2022 approved the Scheme of Amalgamation between BMG Enterprises Limited ("the Transferor Company") and Rossell India Limited ("the Transferee Company") and their respective shareholders under the provisions of Sections 230 to 232 read with Section 66 and other applicable provisions of the Companies Act, 2013 ('the Scheme'). The Appointed Date set out in the Scheme is 1st July, 2022 or such other date as the Hon'ble National Company Law Tribunal ("NCLT") may approve. After receiving the No Objection / Observation Letters for the Scheme from the Stock Exchanges as well as the approval from the Shareholders and Creditors, the petition for approval of the Scheme is pending final disposal before NCLT. The Company has not incurred any expenses for this Scheme as all the expenses in this regard are being borne by the Transferor Company, in terms of the said Scheme.

The Board of Directors of the Company at their Meeting held on 16th December, 2022 approved the Scheme of Arrangement between Rossell India Limited ("the Demerged Company") and Rossell Techsys Limited ("the Resulting Company") and their respective shareholders under the provisions of Sections 230 to 232 read with Section 66 and other applicable provisions of the Companies Act, 2013 involving demerger of Rossell Techsys Division from the Demerged Company into the Resulting Company. The Appointed Date set out in the Scheme is 1st April, 2023 or such other date as the Hon'ble National Company Law Tribunal ("NCLT") may approve. After receiving the No Objection / Observation Letters for the Scheme from the Stock Exchanges as well as the approval from the Shareholders and Creditors, the petition for approval of the Schemes was moved before NCLT, who has already pronounced their final order recently. However, the same is still not being effective pending receipt of Certified Copy from NCLT and filing thereof with the concerned Registrar of Companies.

52. Preferential Allotment of Shares

- 52.1 The Board of Directors by adopting a Resolution by Circulation on 27th June, 2022 allotted 10,00,000 0.01% Compulsorily Convertible Preference Shares (CCPS) (Instruments entirely Equity in nature) of ₹ 10 each at an issue price of ₹ 156 per CCPS including Securities Premium of ₹ 146 per CCPS aggregating to ₹ 1,560 Lakhs on preferential basis (for cash consideration) after obtaining the required regulatory approvals to BMG Enterprises Ltd., the Holding Company. (Allottee)
- 52.2 Subsequently, the Board of Directors at its Meeting held on 16th December, 2022 approved the conversion of aforesaid CCPS of ₹ 10 each into 10,00,000 Equity Shares of ₹ 2 each pursuant to the option exercised by the Allottee as per the Terms of the Preferential Issue. The difference in face value of ₹ 8 per Share aggregating to ₹ 80 Lakhs was treated as further Securities Premium received on such issue and allotment of Equity Shares.
- 52.3 The funds raised from the issue and allotment of the said CCPS have been fully utilised for meeting long term fund requirements and other general corporate purposes of the Company.
- 53. Quarterly returns or statements of current assets filed by the company with banks are in agreement with the books of accounts.

Opinion

We have audited the accompanying Ind AS Consolidated Financial Statements of Rossell India Ltd. ("the Company") and its Subsidiaries (the Company and its Subsidiaries together referred to as "the Group"), which comprise the Consolidated Balance Sheet as at March 31, 2024, the Consolidated Statement of Profit and Loss (including Other Comprehensive Income), the Consolidated Statement of Changes in Equity and the Consolidated Statement of Cash Flows for the year then ended, and Notes to the Consolidated Financial Statements including a summary of the significant accounting policies and other explanatory information.

The audited financial statements of the subsidiary, Rossell Techsys Limited have been incorporated in this Account.

 contain any material mis-statement.
 - e) The dividend declared or paid during the year by the Holding Company are in compliance with section 123 of the Act.
 - f) Based on our examination on test check basis and in accordance with the implementation guide on reporting on audit trail under Rule 11(g) of the Companies (Audit and Auditors) Rules, 2014, we find that the Group, save and except, Rossell Techsys Inc., USA has used accounting software for maintaining its books of accounts for the year ended 31st March, 2024 which has a feature of recording audit trail (edit log) facility and the same has operated throughout the year for transactions recorded in the software during the year. We did not come across any instance of audit trail feature being tampered with.
 - Rossell Techsys Inc., USA, being a Foreign Subsidiary, is not governed by the Companies (Audit and Auditors) Rules, 2014.

- 1. The Board of Directors of the Parent by adopting a Resolution by Circulation on 27th June, 2022 allotted 10,00,000 0.01% Compulsorily Convertible Preference Shares (CCPS) (Instruments entirely Equity in nature) of ₹ 10 each at an issue price of ₹ 156 per CCPS including Securities Premium of ₹ 146 per CCPS aggregating to ₹ 1,560 Lakhs on preferential basis (for cash consideration) after obtaining the required regulatory approvals. Accordingly, ₹ 1,460 lakhs have been credited here.
- 2. Further, the Board of Directors of the Parent at its Meeting held on 16th December, 2022 approved the conversion of aforesaid CCPS of ₹ 10 each into 10,00,000 Equity Shares of ₹ 2 each persuant to the option exercised by the Allottee as per the Terms of the Preferential Issue. The difference in face value of ₹ 8 per Share aggregating to ₹ 80 Lakhs was treated as further Securities Premium received on such issue and allotment of Equity Shares.

Nature and purpose of each Reserve

Capital Reserve

This represents the amounts received as compensation for Tea Estates Land acquired by competent authorities on various occassions as well as certain adjustments relating to various Schemes of Arrangements, which the Parent had entered in to in the earlier years.

b) Securities Premium Reserve

Securities Premium Reserve was created as per the Scheme of Arrangement with the value of net assets taken over by the Parent and again used to credit the premium on issue of Equity Shares by the Parent from time to time, including the present issues (Notes 1 and 2 above). The reserve is available for utilisation in accordance with the provisions of the Companies Act, 2013.

c) General Reserve

General Reserve is created for ploughing back the profits earned by the Parent and retained before payment of dividend. This is free reserve and available for utilisation in accordance with the provisions of the Companies Act, 2013.

Retained Earnings

Retained earnings represent accumulated profits earned by the Group and remaining undistributed as on date.

Notes to the Consolidated Financial Statement for the Year ended 31st March, 2024

1. Company Overview

Rossell India Limited (the Holding Company/ the Parent) is a Public Limited Company incorporated and domiciled in India. The Holding Company was incorporated on 10th June, 1994 under the Companies Act, 1956 with its registered office at Kolkata, West Bengal. The Equity Shares of the Holding Company are listed on National and Bombay Stock Exchanges. The Holding Company is engaged in the following business activities:

a. Cultivation, Manufacture and Sell of Bulk Tea as Rossell Tea Division.

Engineering and Manufacturing in Aerospace and Defense Services as Rossell Techsys Division.

Rossell Techsys Inc. (the Subsidiary Company/ Subsidiary) is a Delaware Corporation, incorporated in the State of Delaware, USA. The Company was incorporated on 6th August, 2021 under General Corporation Law of Delaware, USA with its registered office at County of Sussex, Delaware. Rossell Techsys Inc., USA is engaged in the management and operations of its business related to the aerospace and airline industry and in connection therewith also provides certain services and activities to support the ongoing functions and requirements of other businesses operating in such industries.

Rossell Techsys Limited (the Subsidiary Company/ Subsidiary) is a Public Limited Company incorporated and domiciled in India. The Company was incorporated on 6th December, 2022 under the Companies Act, 2013 with its registered office at Kolkata, West Bengal. This Company was incorporated for taking over the existing undertaking of Rossell Techsys Division as per the Scheme of Arrangement (Note 49) already approved and sanctioned by the Hon'ble National Company Law Tribunal, Kolkata Bench recently. The Scheme shall become effective immediately upon filing the certified true copy of the Order with the Registrar of Companies, West Bengal. The Company has not taken up any Business Activity as yet. It is expected to commence commercial activity as soon as the said Scheme becomes effective.

2.1 Basis of Preparation

These Consolidated Financial Statements of the Group, comprising of the Parent and Subsidiaries have been prepared in accordance with Indian Accounting Standard (Ind AS 110) as per Companies (Indian Accounting Standards) Rules, 2015 (as amended) notified under Section 133 of the Companies Act, 2013 (the Act) and the other relevant provisions of the Act and Rules made thereunder.

Since the Subsidiary company, Rossell Techsys Limited was incorporated on 6th December, 2022 and became Wholly Owned Subsidiary on 16th December, 2022. Accordingly, the Consolidated Accounts include the Financial Results of the Subsidiary company, Rossell Techsys Limited for the Financial Year 2022-23 from 16th December, 2022 to 31st March, 2023. Thus previous year's figures are not comparable.

2.2 Consolidation Procedure

Consolidated Financial Statements:

- (a) Combine like items of assets, liabilities, equity, income, expenses and cash flows of the Parent with that of the Subsidiaries;
- (b) Offset (eliminate) the carrying amount of the Parent's Investment in the Subsidiaries and the Parent's portion of equity of such Subsidiaries;
- (c) Eliminate in full intergroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group.

2.3 Basis of Measurement

The Consolidated Financial Statement has been prepared on a historical cost basis except the following items:

- a) Certain financial assets and liabilities (including derivative instruments) which are measured at fair value.
- Biological Assets other than Bearer Plants, which are measured at fair value less cost to sell.
- Defined benefit plans plan assets measured at fair value.

2.4 Use of estimates and judgements

The preparation of financial statements in accordance with Ind AS requires management to use certain critical accounting estimates and assumptions. It also requires management to exercise judgment in the process of applying accounting policies. Actual results could differ from those estimates. These estimates, judgments, assumptions affect application of the accounting policies and the reported amounts of assets, liabilities, revenue, expenditure, contingent liabilities etc.

The estimates and underlying assumptions are reviewed on an ongoing basis and changes are made as management becomes aware of changes in the circumstances surrounding the estimates. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the Company and that are believed to be reasonable under the circumstances. Revisions to accounting estimates are recognized in the financial statements in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods, if the revision affects both current and future periods.



2.5 **Basis of Consolidation**

Subsidiaries

Subsidiaries are the entities controlled by the Group. This control comes on an entity when the group is exposed to, or has rights to, variable returns from its involvement with that entity and has the ability to affect those returns through its power over that entity. The Financial Statements of Subsidiaries are included in the Consolidated Financial Statements from the date on which the control commences and till the date control ceases.

26 Classification of current and non-current

All assets and liabilities have been classified as current or non-current as per the Holding and Subsidiary Companies normal operating cycle and other criteria set out in the Ind AS 1 – Presentation of financial statements and Schedule III to the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalents, all the Companies have ascertained the operating cycle as 12 months for the purpose of current / non-current classification of assets and liabilities.

2.7 Share of Profit (Loss) of Subsidiary Companies

Based on Consolidated Financial Statements prepared in accordance with the above basis, the amount of Net Assets, share of Profit / (Loss) of Subsidiaries and amount of Other Comprehensive Income (OCI) as attributable to Parent has been ascertained as under:

3 **Material Accounting Policies**

The following Material Uniform Accounting Policies have been adopted by both Parent and Subsidiaries and accordingly by the Group for preparing these Consolidated Financial Statements

3.1 Property, Plant and Equipment

3.1.1 Tangible Assets (Other than Bearer Plants)

Property, Plant and Equipment are measured at cost / deemed cost, less accumulated depreciation and impairment losses, if any. Cost of Property, Plant and Equipment comprises its purchase price, including import duties and non-refundable purchase taxes, after deducting trade discounts and rebates, any directly attributable cost of bringing the item to its working condition for its intended use and estimated attributable costs of dismantling and removing the item and restoring the site on which it is located. Deemed Cost is the carrying value of all of its Property, Plant and Equipment (other than Bearer Plants) as of 1st April, 2016 measured as per the previous GAAP as the Group elected to continue with the same carrying value as on the aforesaid transition date for Ind AS.

Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced. All other repairs and maintenance are charged to the Statement of Profit and Loss during the reporting period in which they are incurred.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount. Any gain or loss on disposal of an item of Property, Plant and Equipment is recognized in Statement of Profit and Loss.

An item of Property, Plant and Equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of asset. Any gain or loss arising on the disposal or retirement of an item of Property, Plant and Equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognized in profit or loss.





Items of Property, Plant and Equipment are depreciated in a manner that amortizes the cost of the assets less its residual value, over their useful lives on a straight line basis. Estimated useful lives of the assets are as specified in Schedule II of the Companies Act, 2013, except for Bearer Plants, where the residual value is taken as Nil.

The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period and the effect of any changes in estimate is accounted for on a prospective basis.

3.1.2 Bearer Plants

Bearer Plants comprising of mature tea bushes as well as matured black pepper vines and shade trees are stated at cost / deemed cost less accumulated depreciation and impairment losses, if any.

The cost of uprooting of old tea bushes, rehabilitation of land, replanting and young tea upkeep and maintenance up to the year 3 from the year of planting are capitalized as mature plants, capital work-in-progress. From year 4 onwards capital work-in-progress is treated as Bearer Plants and depreciated using Straight Line Method over the expected useful life of 70 years, when the Bearer Plants (mature tea bushes) reaches maturity stage with residual value as 'Nil'.

Depreciation on Bearer Plants is recognized so as to write off its cost over useful lives, using the Straight Line Method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any change in estimate accounted for on a prospective basis.

3.1.3 Intangible Assets

Intangible Assets comprise acquired Computer Software having a finite life. Cost of software is capitalized when it is expected to provide future enduring economic benefits. The capitalization cost includes license fee, cost of implementation and system integration services. The costs are capitalized in the year in which the relevant Software is implemented for use and is amortized across a period not exceeding 10 years.

3.1.4 Research and Development

Research and Development costs are expensed as incurred, unless technical and commercial feasibility of the project demonstrate that: (a) the future economic benefits are available, (b) the activity is being carried out with an intention and ability to complete as well as use the asset and (c) the costs can be measured reliably. In such case, the cost is capitalized as Intangible Asset - Knowhow. The costs which can be capitalized include the cost of material, direct labour, overhead costs including finance cost, if applicable that are directly attributable to bringing the asset for its intended use.

3.2 Foreign Currency Translation

Foreign currency transactions are translated into Indian Rupee (INR) which is the functional currency (i.e. the currency of the primary economic environment in which the entity operates) using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are recognized in profit or loss.

For translation of Financial Statement of the Subsidiary denominated in USD into INR, the year-end exchange rate has been considered for items of assets and liabilities thereof. While the average exchange rate has been taken for items of income and expenses of the Subsidiary as per Indian Accounting Standard Ind AS 21, The Effects of Changes in Foreign Exchange Rates'.

3.3 Revenue Recognition

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are inclusive of insurance claim for damage / shortage of finished goods and are net of sales return, GST and trade allowances.

The Group recognizes revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the Group and significant risk and reward incidental to sale of products is transferred to the buyer or services are rendered as per terms of the relevant contract.



3.3.1 Financial Instruments

Financial assets and financial liabilities are recognized when the entity becomes a party to the contractual provisions of the relevant instrument and are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issues of financial assets and financial liabilities (other than financial assets and financial liabilities measured at fair value through profit or loss) are added to or deducted from the fair value measured on initial recognition of financial assets or financial liabilities. Purchase or sale of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognized on the trade date i.e. the date when the Group commits to purchase or sell the asset.

3.3.2 Financial Assets

Recognition and Classification

The financial assets are classified at initial recognition in the following measurement categories as:

- those subsequently measured at amortized cost.
- those to be subsequently measured at fair value [either through other comprehensive income (OCI), or through profit or loss]

Subsequent Measurement

- Financial assets measured at amortized cost Financial assets which are held within the business model of collection of contractual cash flows and where those cash flows represent payments solely towards principal and interest on the principal amount outstanding are measured at amortized cost. A gain or loss on a financial asset that is measured at amortized cost and is not a part of hedging relationship is recognized in profit or loss when the asset is derecognized or impaired.
- Financial assets measured at fair value through other comprehensive income Financial assets that are held within a
 business model of collection of contractual cash flows and for selling and where the assets' cash flow represents solely
 payment of principal and interest on the principal amount outstanding are measured at fair value through OCI. Movements
 in carrying amount are taken through OCI, except for recognition of impairment gains or losses. When a financial asset, other
 than investment in equity instrument, is derecognized, the cumulative gain or loss previously recognized in OCI is reclassified
 from equity to statement of profit and loss.
 - Classification of equity instruments, not being investments in subsidiaries, associates and joint arrangements, depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through OCI. When investment in such equity instrument is derecognized, the cumulative gains or losses recognized in OCI is transferred within equity on such derecognition.
- Financial assets measured at fair value through profit or loss Financial assets are measured at fair value through profit or loss unless it is measured at amortized cost or at fair value through other comprehensive income on initial recognition. Movements in fair value of these instruments are taken in profit or loss.

Impairment of financial assets

The Group assesses at each date of balance sheet whether a financial asset or a group of financial assets is impaired. Impairment losses are recognized in the profit or loss, where there is an objective evidence of impairment based on reasonable and supportable information that is available without undue cost or effort. For all financial assets, expected credit losses are measured at an amount equal to the 12 month expected credit losses or at an amount equal to the life time expected credit losses if the credit risk on the financial asset has increased significantly since initial recognition. The Group recognizes loss allowances on trade receivables when there is an objective evidence that the Group will not be able to collect all the due amount depending on product categories and the payment mechanism prevailing in the industry.

Income recognition on financial assets

Interest income from financial assets is recognized in profit or loss using effective interest rate method, where applicable.

Dividend income is recognized in profit or loss only when the Group's right to receive payments is established and the amount of dividend can be measured reliably.





3.3.3 Financial Liabilities

Financial liabilities are classified according to the substance of the contractual arrangements entered into. Financial liabilities are classified, at initial recognition, as subsequently measured at amortized cost unless they fulfill the requirement of measurement at fair value through profit or loss. Where the financial liability has been measured at amortized cost, the difference between the initial carrying amount of the financial liabilities and their redemption value is recognized in the statement of profit and loss over the contractual terms using the effective interest rate method. Financial liabilities at fair value through profit or loss are carried at fair value with changes in fair value recognized in the finance income or finance cost in the statement of profit or loss.

3.3.4 Derecognition of financial assets and financial liabilities

Financial assets are derecognized when the rights to receive benefits have expired or been transferred, and the Group has transferred substantially all risks and rewards of ownership of such financial asset. Financial liabilities are derecognized when the liability is extinguished that is when the contractual obligation is discharged, cancelled or expired.

3.3.5 Offsetting of financial instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet where there is a legally enforceable right to offset the recognized amounts and there is an intention to settle on a net basis or realize the asset and settle the liability simultaneously.

3.4 Derivatives and hedging activities

The Group at times, do have derivative financial instruments such as forward contracts to mitigate risk of changes in exchange and interest rates, although it was Nil outstanding as on 31st March, 2024. The counterparty for these contracts is generally banks.

3.4.1 Derivatives

Derivatives are measured at fair value. All fair value gains and losses are recognized in profit and loss except where the derivatives qualify as hedging instruments in cash flow hedges or net investment hedges.

3.4.2 Cash flow hedges that qualify for hedge accounting:

The Group designates their derivatives as hedges of foreign exchange risk associated with the cash flows of highly probable forecast transactions.

The Group documents at the inception of the hedging transaction the economic relationship between hedging instruments and hedged items including whether the hedging instrument is expected to offset changes in cash flows of hedged items.

The effective portion of changes in the fair value of derivatives that are designated and qualify as cash flow hedges is recognized in the Other Comprehensive Income.

3.5 Government Grants

Grants from the government are recognized at their fair value where there is a reasonable assurance that the grant will be received and the entity will comply with all attached conditions.

Government grants relating to income are deferred and recognized in the Statement of Profit and Loss over the period necessary to match them with the costs that they are intended to compensate and presented within other income.

Government grants relating to the purchase of Property, Plant and Equipment are included in non-current liabilities as deferred income and are credited to the Statement of Profit and Loss on a Straight Line basis over the useful life of the related assets and presented within other income.



3.6 Income Tax

The Income Tax expense or credit for the period is the tax payable on the current year's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses as well as available MAT Credit.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the reporting date. Current tax comprises of expected tax payable or receivable on taxable income / loss for the year or any adjustment or receivable in respect of previous year.

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognized for all taxable temporary differences. Deferred tax assets are generally recognized for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized. Such deferred tax assets and liabilities are not recognized if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Current and deferred tax are recognized in profit and loss, except when they relate to items that are recognized in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognized in other comprehensive income or directly in equity respectively.

3.7 **Inventories**

Stock of finished goods and stock-in-trade are valued at lower of cost and net realizable value. Finished goods, produced from agricultural produce viz. Black Tea and Tea Waste, are valued at lower of cost arrived at by adding the cost of conversion to the fair value of agricultural produce viz. Green Leaves and the net realizable value. Agricultural produces, viz. Green Leaves harvested from the Company's own Tea Estates, are valued at fair value less cost to sell at the point of harvest. Black Pepper, being an Agricultural Produce is also valued at the net realizable value.

Raw Materials purchased (including Bought Green Leaves) and Stores and Spare Parts are valued at or under cost. Work-in-progress is valued at works cost based on technical evaluation of the stage of completion.

Provision is made for obsolete, slow moving and defective inventories, wherever necessary and reviewed from time to time.

Costs are ascertained to the individual item of inventory by adopting weighted average method. Net realizable value is the estimated selling price for inventories less all selling costs.

3.8 **Biological Assets**

Biological Assets comprises of unharvested Green Tea Leaves. These are recognized as such when and only when, (a) the Group controls the assets as a result of past events, (b) it is probable that future economic benefits associated with such assets will flow to the Group and (c) the fair value or cost of assets can be measured reliably. These assets are measured at its fair value less cost to sell. The gain or loss arising from change in such value is included in Statement of Profit and Loss.

3.9 **Agricultural Produce**

Agricultural Produce comprises of harvested Green Tea Leaves as well as Black Pepper, from its own Tea Estates. These are valued at fair value less cost to sell on the reporting date. The gain or loss arising from change in such value is included in the Statement of Profit and Loss under the head Consumption of Raw Materials (Green leaves) or Change in inventories of Finished Goods, as applicable.





3.10 Employee Benefits

- 3.10.1 These are recognized at the undiscounted amount as expense for the year in which the related service is rendered.
- **3.10.2** The Parent is contributing regularly to the Provident Funds, administered by the Governments and independent of Company's finances, in respect of all its eligible employees. The Parent also operates Defined Contribution Scheme for payment of Pension to certain classes of employees. Monthly contribution at 15% of the eligible employees' current salary is made to recognized Superannuation Fund, which is fully funded. This Fund is administered by Trustees and is independent of Parent's finance. Contributions are recognized in Profit and Loss Statement on an accrual basis.
- 3.10.3 Defined Benefit Gratuity Plan is also maintained by the Parent. The Parent contributes to the recognized Gratuity Fund, which is administered by the Trustees and is independent of Parent's finance. The Annual Contribution is determined by the actuary at the end of the year. Actuarial gains and losses are recognized in the Profit and Loss Statement. The Parent also recognizes in the Profit and Loss Statement gains or losses on curtailment or settlement of the defined benefit plan as and when the curtailment or settlement occurs.

Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognized, in the year in which they occur, directly in Other Comprehensive Income and eventually included in retained earnings in the Statement of changes in Other Equity and in the Balance Sheet.

Changes in the present value of the defined benefit obligation resulting from plan amendments or curtailments are recognized immediately in the Statement of Profit and Loss as past service cost.

3.10.4 Leave encashment liability for eligible employees is provided for at the end of the year, as actually computed and paid/provided for and the charge is recognized in the Profit and Loss Statement.

3.11 Leases

Leases are recognized as per Ind AS 116 when there is a contract that conveys the right to control the use of an identified asset. Such leases are amortized over the lease term.

3.12 Borrowing costs

Borrowing costs consist of interest and related costs incurred in connection with the borrowing of funds. Borrowing costs also include exchange differences to the extent regarded as an adjustment to the borrowing costs.

Borrowing costs that are attributable to the acquisition or construction of qualifying assets or for self-created assets (i.e. an asset that necessarily takes a substantial period of time to get ready for its intended use) are capitalized as a part of the cost of such assets. All other borrowing costs are charged to the Statement of Profit and Loss.

3.13 Provisions and Contingent Liabilities

Provisions are recognized when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

The amount recognized as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation.

Contingent liabilities are possible obligations whose existence will only be confirmed by future events not wholly within the control of the Group or present obligations where it is not probable that an outflow of resources will be required or the amount of the obligation cannot be measured with sufficient reliability.

Contingent liabilities are not recognized in the financial statements but are disclosed unless the possibility of an outflow of economic resources is considered remote.

3.14 Operating Segments

In terms of Ind AS 108, Operating segments are reported in a manner consistent with the internal reporting provided to the Chief Operating Decision Maker (CODM) viz. the Chief Executive Officer (Executive Chairman) of the Group. The CODM is responsible for allocating resources and assessing performance of the operating segments, which are engaged in separate business activities from which it earns revenue and incur expenses. For each of the segments discreet Financial Results are available.

44. Financial risk management objectives

The Parent's business activities expose it to certain financial risks - market risk, liquidity risk and credit risk. In order to minimize those risks, the Parent has risk management policies and procedures in place as approved by the Audit Committee of the Board of Directors of the Parent after due evaluation of key risks facing the business of the Company:

a) Market Risk

The Parent's business of Cultivation, Manufacture and Sale of Tea is primarily agricultural in nature and subject to vagaries of nature. Moreover, the sale price of Tea is largely determined by the market forces of demand and supply. Thus, adverse weather conditions and uncertain tea market expose it to the risk that the fair value or future cash flows may adversely fluctuate. The Parent closely monitors the changes in market conditions and select the sales strategies to mitigate its exposure to various market risks. Other Market risks are as under:

i. Foreign Currency Risk

The Parent undertakes significant transactions denominated in foreign currency with its customers in relation to Exports by Rossell Tea Division and 100% EOU of Rossell Techsys Division. This results in wide exposure to exchange rate fluctuations. Such exchange rate risk primarily arises from transactions made in foreign exchange and reinstatement risks arising from recognized assets and liabilities, which are not in the Company's functional currency (Indian Rupees). A significant portion of these transactions are in US Dollar, Euro, British Pound Sterling etc.

The Parent, as Risk Management Policy, hedges its exposure in foreign exchange whenever considered appropriate based on the their perception about such market and reviews periodically its exposure therein to ensure that results from fluctuating currency exchange rate are appropriately managed.

ii. Interest Rate Risk

Interest rate risk refers to the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The objectives of the Parent's interest rate risk management processes are to lessen the impact of adverse interest rate movements on its earnings and cash flows and to minimize counter party risks.

The Parent is exposed to interest rate volatilities primarily with respect to its borrowings from Banks. Such volatilities primarily arise due to changes in the Lending rates of Banks, which in turn are linked with Repo Rates as announced by RBI from time to time as well as other economic parameters of the Country. The Parent manages such risk by operating with Banks having strong fundaments with comparatively lower Lending Rates in the Market.

Interest rate sensitivity

Since the significant amount of borrowings of the Parent are short term in nature, the possible volatility in the interest rate is minimal.





b) Liquidity Risk

Liquidity risk is the risk that the Group may encounter difficulty, including seasonality, in meeting its obligations due to shortage of liquid assets.

The Group mitigates its liquidity risks by ensuring timely collections of its trade receivables, close monitoring of its credit cycle, ensuring optimal movements of its inventories and avoid blockage of working capital in non-productive current assets.

c) Credit Risk

Credit risk is the risk that counter party will not meet its obligations leading to a financial loss to the Group.

The Subsidiary exposure is limited to its parent. The Parent has its policies to limit its exposure to credit risk arising from outstanding receivables. Management regularly assess the credit quality of its customers based on which, the terms of payment are decided. Credit limits are set for each customer which are reviewed at periodic intervals. The credit risk of the Parent is low as the Parent sells a significant volume of its Teas through the auction system which is on cash and carry basis. The exports are made mostly to worldwide reputed Corporates like Boeing, Lockheed Martin and Taylors of Harrogate etc., and otherwise backed by letter or credit or on advance basis.

There is no expected credit risk on Trade Receivables as on 31st March, 2024 (Note 15).

The Board of Directors of the Parent at their Meeting held on 12th July, 2022 approved the Scheme of Amalgamation between BMG Enterprises Limited ("the Transferor Company") and Rossell India Limited ("the Transferee Company") and their respective shareholders under the provisions of Sections 230 to 232 read with Section 66 and other applicable provisions of the Companies Act, 2013 ('the Scheme'). The Appointed Date set out in the Scheme is 1st July, 2022 or such other date as the Hon'ble National Company Law Tribunal ("NCLT") may approve. After receiving the No Objection / Observation Letters for the Scheme from the Stock Exchanges as well as the approval from the Shareholders and Creditors, the petition for approval of the Scheme is pending final disposal before NCLT, which is pending for final hearing. The Parent has not incurred any expenses for this Scheme as all the expenses in this regard are being borne by the Transferor Company, in terms of the said Scheme.

The Board of Directors of the Parent Company at their Meeting held on 16th December, 2022 approved the Scheme of Arrangement between Rossell India Limited ("the Demerged Company") and Rossell Techsys Limited ("the Resulting Company") and their respective shareholders under the provisions of Sections 230 to 232 read with Section 66 and other applicable provisions of the Companies Act, 2013 involving demerger of Rossell Techsys Division from the Demerged Company into the Resulting Company. The Appointed Date set out in the Scheme is 1st April, 2023 or such other date as the Hon'ble National Company Law Tribunal ("NCLT") may approve. After receiving the No Objection / Observation Letters for the Scheme from the Stock Exchanges as well as the approval from the Shareholders and Creditors, the petition for approval of the Schemes was moved before NCLT, who has already pronounced their final order recently. However, the same is still not being effective pending receipt of Certified Copy from NCLT and filing thereof with the concerned Registrar of Companies.

50. In terms of Guidelines Note on Audit of Consolidated Financial Statements issued by the Institute of Chartered Accountants of India, General Circular No. 39/2014 dated 14th October, 2014 issued by the Ministry of Corporate Affairs and provisions of Indian Accounting Standard Ind AS 110, only those disclosures are given as are relevant to these Consolidated Financial Statement to give a true and fair view thereof.
