This has not resulted in any change in control over the Target Company. Venture Drive Limited (Cayman Islands), Uniphos (Cayman Islands) and Victory Trust are part of the "group" of the Target Company within the meaning of the term "group" defined in the Monopolies and Restrictive Trade Practices Act, 1969. Accordingly, the transfer of shares of Uniphos (Cayman Islands) by Venture Drive (Cayman Islands) to Victory Trust is exempt in terms of Regulation 3(1)(e)(i) of the SEBI SAST Regulations.

There is no direct acquisition or transfer of shares in the Target Company and there is no change in control over the Target Company.
