with R.O.C on 19<sup>th</sup> July, 2010, thus the Amalgamation is effective from 19<sup>th</sup> July, 2010 with appointed date being 1<sup>st</sup> April, 2009.

6. 172000000 Equity Shares of Re.1/- each of Nila Infrastructures Ltd have been allotted on 24/07/2010 to the Shareholders of Pearl Stockholdings Pvt. Ltd in the ratio of 86 equity shares of Rs.1/- each of the Transferee Company for every 10 equity shares of Re.1/- each held in the Transferor Company.
