 2. During the quarter no investor complaints were received, There were no complaints pending at the beginning and end of the quarter.
 3. The Company operates in only one segment - Reed Switches.
 4. The auditors have qualified their audit report on the accounts of the company for the year ended 31-03-2010 as follows:
 Despite substantial erosion of networth, the accounts for the year have been prepared on the basis that the company is a "going concern".

Management comment:

Consequent to total erosion of the company's networth, as on 30-06-2005, the report as required under section 23 of the Sick Industrial Companies (Special Provisions) Act 1985 was submitted to the Board for Industrial and Financial Reconstruction (BIFR) on 06-02-2006. BIFR has declined the registration on technical grounds vide its letter dated 30th March 2006. As the networth became positive as at 31st March 2006, the company did not pursue it further. The Management is taking steps to improve the profitability of the company by increasing the production of switches with higher margin and introduction of additional product lines such as proximity switches, high vacuum switches, etc, which will give a higher contribution. As the company has achieved cash profits for the year 2005-06, 2006-07, 2007-08, 2008-09 & 2009-10 the management is confident that the operations of the company would improve, and hence the accounts have been prepared on a "going concern" basis.
 5. Provision for Employees Retirement Benefits have been made on the basis of Actuarial Valuation as per Accounting Standard AS-15, but not funded due to cash flow problems.
