
(\*) The accumulated loss of the Company is more than its reserves. Therefore the same is not reflected against Item No. 16.



**Notes:**

1. The above results were reviewed by the Audit Committee of Directors, thereafter taken on record by the Board of Directors in their meeting held on 11.02.2011 and a Limited Review of the same has been carried out by the Statutory Auditors of the Company.
2. The Company has not recognised Deferred Tax Assets in excess of Deferred Tax Liabilities, as a matter of prudence.
3. No Provision has been made in respect of interest on Deposits/Debentures/Subordinated Debts after 1<sup>st</sup> July 2002 and on the Loans given against said securities for the reason that the Company had presented a scheme of restructure of Debts before the Honorable High Court of Karnataka. However the Company has withdrawn the aforesaid scheme on 28.10.2009, with a liberty to present as fresh scheme. Accordingly the Company is exploring the possibilities of presenting a new scheme. No provision made for interest on Deposits after 1<sup>st</sup> July 2002.
4. Interest write back on Deposits/Debentures/Debt on settlement with depositors/debenture/Debt holders for the nine months period ending 31<sup>st</sup> December 2010 (for the nine months period ending 31<sup>st</sup> December 2009 is Rs. 52.91 lakhs and for the year ending 31<sup>st</sup> March 2010 Rs. 71.27 lakhs) is considered in the above statement as extraordinary item Rs. 17.08 lakhs. The corresponding amount for the Quarter ended 31<sup>st</sup> December 2010 is Rs. 5.09 lakhs and 31<sup>st</sup> December 2009 is Rs. 34.71 lakhs. The principal portion written back on such settlement is being directly taken to Balance Sheet as Capital Reserve. This amount for the nine months period ending 31<sup>st</sup> December 2010 is Rs. 79.60 lakhs. The amount for the year ending 31<sup>st</sup> March 2010 is Rs. 379.11 lakhs. The amounts as aforesaid for the nine months period ending 31<sup>st</sup> December 2009 is Rs. 247.95 lakhs. The corresponding amount for the quarter ending 31<sup>st</sup> December 2010 is Rs.25.70 lakhs (quarter ending 31<sup>st</sup> December 2009 is Rs. 153.22 lakhs)
5. The Company has been incurring losses for the last few years mainly on account of provision against non performing assets. The accounts have been prepared on a going concern basis, as the Company's management is hopeful of recovery of dues from Non-Performing accounts as well as other debtors and also in view of the fact that the Company is exploring the possibility of presenting a new scheme of restructure of debts before the Honorable High Court of Karnataka.
6. The Company does not foresee any diminution in the value of investments.
7. Provision for non-performing assets of RS. 66 lakhs (as on 31.12.2009 Rs. 483.43 lakhs) has not been considered in the above result as it feels the provision already made in the books are sufficient.
8. The figures for the previous period are regrouped, rearranged and reclassified wherever necessary.
9. Since the Company does not have business in more than one segment, segment-wise reporting on Revenue, Results and Capital Employed is not applicable.
