- Consolidated Total Income stood at Rs 123.8 crore
- EBITDA Margin stood at 11.4% as against 8.5% in Q1FY13; an increase of 299 bps.
- Consolidated Net Profit for the quarter stands at Rs 1.9 crore
- Basic EPS for the quarter stood at Rs 0.40 on a face value of Rs. 5.

Commenting on the results, Mr. Nitin Shah, Chairman and Managing Director said "While we have managed to stabilize the business at an operating level, we still see the Indian market to be challenging and we believe that this will last for another six months at the least. However, we are seeing some good traction in the US and UK markets and we are hopeful that this will translate into a good order book position for the Company."

He also added, "The focus of the Company has been to work on operational efficiency measures coupled with judicious choice of projects that we take on board and this has translated into a second successive quarter where our EBITDA margins have increased by almost 300 bps."
