- The Un-audited Financial Results have been reviewed by the Audit Committee and approved by the Board at their respective meetings held on May 18, 2012.
- The above results for the quarter ended March 31, 2012 have been reviewed by the Statutory Auditors of the Company.
- Details of investor complaints for the quarter ended March 31, 2012 : beginning Nil, received - 4, disposed off - 4 and pending - Nil.
- Provision for Taxation includes Deferred Tax expense computed in accordance with Accounting Standard - 22 'Accounting for Taxes on Income' notified under Section 211 (3C) of the Companies Act, 1956.
- The Company has made a strategic investment of Rs 45.52 crores in Mail Today Newspapers Private Limited (Mail Today) for entering into print media. Though, Mail Today is in the initial stages of operations and is presently incurring losses, the Company is confident of its future profitability and consequently of the carrying value of the investment. The Auditors' have included this in their review report without qualification.
- During December 2011 quarter, fire took place at one of the premises of the Company under construction resulting in a loss of Rs.69.24 lacs to the company's properties. Pending settlement of claim by the Insurance Company, the loss was provided for in the said quarter. However, the said claim will be shown as income as and when settled.
- The figures for the previous quarter / period have been regrouped / rearranged, wherever considered necessary, to conform to the current quarter classification.
- The figures of last quarter ( col.A & C ) are the balancing figures between the audited figures in respect of full financial year and published year to date figures up to the third quarter of the respective financial year and have not been separately audited.
