## LIMITED REVIEW REPORT

1. We have reviewed the accompanying statement of unaudited financial results of **SUJANA TOWERS LIMITED, HYDERABAD** as at 30<sup>th</sup> June 2012 except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.
2. We conducted our review in accordance with the Standard on Review Engagement (SRE) 2400, "*Engagements to Review Financial Statements*" issued by the Institute of Chartered Accountants of India (ICAI). This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
3. Attention is invited to:
  - (a) Confirmation / Reconciliation of Balances from few Banks, Unsecured Loans, Debtors, Creditors, Loans and Advances and Other Liabilities are pending. The impact if any on receipt of confirmation / completion of reconciliation is unascertainable at this stage and not provided for.
  - (b) Provision towards Leave Encashment and Gratuity has been made based on management estimate and not based on actuarial valuation.
  - (c) The Statement includes total revenue of Rs.2.86 lacs, expenditure of Rs.124.91 lacs and Loss of Rs.122.05 of the subsidiaries which have not been reviewed by us and these have been consolidated based on the accounts prepared by the Management.
