Dear Sir/Madam,

This is to inform the stock exchanges that the Company has signed a MOU with Stone Intermodal Pvt Limited (hereinafter referred as "SIPL") for manufacture/supply of Inter model rail road trailers. CEBBCO shall manufacture the first 5 rakes (each rake consist of 50 trailers) of rail road trailers for SIPL on exclusive basis and post that CEBBCO shall have right of first refusal on all trailers that SIPL will get manufactured in India.

CEBBCO shall further provide its facilities for repairs and maintenance of the said trailers (terms & conditions yet to be finalized).
